- 2) Ambarish s/o Munivenkatappa is my friend. During accident Ambarish riding a Motorcycle behind my Motorcycle at a distance of 10 meters.
- 3) It is false to suggest that in the place of alleged accident Bolero vehicle bearing Reg. No.AP-03-TK-4083 was not present and I fell along with the Motorcycle suffered injuries. On 25.05.2023 police informed that Murugan in the owner of the Bolero pick up vehicle. Shivakumar and Ambarish does not know Murugan.
- 4) After incident I went to Kuppam Medical college hospital. I have produced MLC Register Extract issued by Kuppam Medical college hospital. Shivakumar and Ambarish have shifted me to Kuppam Medical college hospital.

- 5) I have passed PUC. There is english subject in PUC.

- 6) It is true to suggest that in the MLC Register Extract issued by V.Kota hospital, marked at Ex.P.22, the history is noted as “H/o RTA (Road Traffic Accident) he came to casualty (COT) CHC, V.Kota on 07.05.2023 at 7.10 p.m., on examination of patient conscious, coherent, PR 78/ min, BP110/80 mm of hg Alcoholic breath smell, slurred speech, pupils dilated, reactive to light”.

- 7) It is false to suggest that in the alleged incident I neither suffered greivous injuries nor took treatment in any hospital as inpatient nor spent Rs.10 lakhs. It is false to suggest that as on the date of alleged incident I never earning Rs.20,000/- per month.

- 8) It is false to suggest that as on today I am not facing any difficulties to perform my day-to-day activities and duties.

- 9) It is false to suggest that I have filed false affidavit and deposed false evidence.
