**Cross Examination by Sri.NMP Advocate for R2 / Insurance company :**

- 1) During accident I was riding Honda Shine two wheeler at distance of 25 to 30 feet from the place of accident. It is true to suggest that during 6.45 to 7.00 p.m., accident taken place. After causing accident at some distance Bolero vehicle became stationery. I do not know whether after accident Bolero vehicle remained in the same place or left. I went near Bolero vehicle and verified the same. I do not know in the incident which part of the Bolero vehicle was damaged.
- 2) It is false to suggest that Bolero vehicle neither caused accident nor I verified Bolero vehicle therefore I do not know which part of the Bolero vehicle was damaged.
- 3) Myself and Balaji.G., (Petitioner) are residents of same village. I do not know the name of the owner of the Bolero vehicle.
- 4) During incident Shivakumar is with me. After incident I have shifted Balaji to Government hospital, V-Kota. I have

informed reason for the injuries suffered by Balaji to doctors of Government hospital, V-Kota. Through mobile I have informed the incident to relatives of Balaji who then came to Government hospital, V-Kota.

- 5) I have not informed the identification number of the vehicle which caused accident to Balaji to relatives of Balaji. In view of tension relatives of Balaji have not asked identification of the vehicle which was the reason for the injuries suffered by Balaji, therefore I have not furnished same information to them.
- 6) When once I have admitted Balaji to Government hospital, V-Kota I never visited the same hospital again. I do not know filing of the complaint by wife of Balaji about the accident.
- 7) Police through mobile called me to the police station wherein recorded my statement. It is false to suggest that even though an unknown vehicle caused accident to Balaji, after 6 days before police I stated as if Bolero vehicle bearing Reg. No.AP-03-TK-4083 dashed to the two wheeler of the Balaji.
