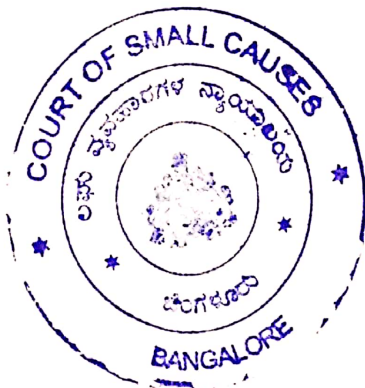

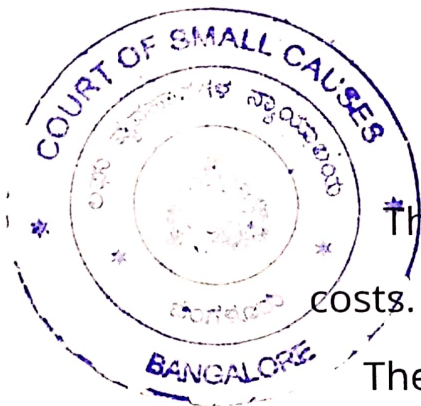

The suit of the plaintiff is hereby decreed with costs.

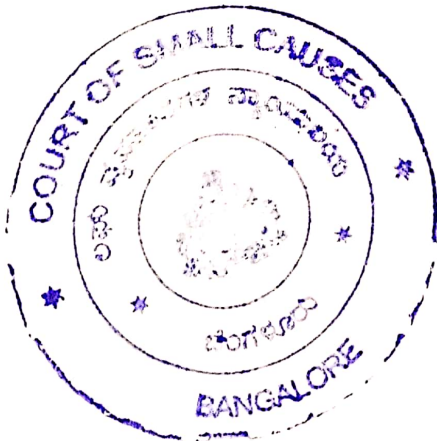
The defendant is liable to pay suit claim of
