

Witness present and duly sworn on 01.08.2025

Cross examination by Ssri.MK Advocate for Respondent no.2:-

(As the witness is unable to stand in the witness box, oath is administered and the evidence is recorded outside the witness box sitting on the chair)

My present age is 67. I am a resident of Pemmashettihalli. I am the RC owner of motorcycle in which I was proceeding at the time of accident. I was riding the said motorcycle. I had DL. I have not produced the said DL because I lost it. I obtained DL in Kolar RTO. It is false to suggest that at the time of accident my motorcycle was not having effective insurance policy and I did not have valid DL.

2. At the time of accident, I was proceeding from the company in which I was working towards Narasapura. Two persons were traveling on the motorcycle. I did not remember the name of the pillion rider. It is true to suggest that the alleged road is national highway road. There was no white stripes either side of the road.

3. The offending car was coming back of my vehicle. It is false to suggest that I was going towards right side of the road. There was a hump. I was trying to take turn to go to right side, at that time the car came and dashed against my vehicle. It is false to suggest that without observing either side of the vehicles, I suddenly took turn towards right side,

thereby the accident occurred. Pillion rider did not suffer any injuries.

4. Back mudguard of motorcycle sustained damages. It is false to suggest that though the accident occurred due to my negligence, in order to suppress the real fact, I am deposing falsehood before this court that the accident occurred due to negligence on the part of driver of offending car. The public took me to Narasapura Govt hospital in the offending car. Thereafter I shifted to SNR hospital, Kolar. I underwent treatment till 5 'o' Clock in the said hospital. Thereafter I was shifted to Gourav hospital, Kolar. I received inpatient treatment for a period of 5 days in Gourav hospital.

5. I sustained right femur fracture. I underwent surgery. I did not remember whether I narrated about accident to the doctors or not. I can produce receipts for payment of Ex.P-9 IP bill after obtaining the same from the concerned hospital. I did not suffer any injuries from any incident prior to accident. It is true to suggest that Ex.P-10 serial no.13 bill was obtained prior to the accident. It is true to suggest that Ex.P-9 serial no.15 bill was handwriting bill. It is false to suggest that Ex.P-9 & 10 medical bills are not related to the accidental injuries bill.

6. I can't produce any documents to substantiate my avocation and income. It is false to suggest that in order to get

compensation, I am deposing falsehood before this court as I was working security guard. It is false to suggest that I have not incurred Rs.2,00,000/-towards medical expenses. It is false to suggest that I deposed falsehood in para-4 of my chief affidavit. My injuries are healed, however I am still having pain.

7. It is false to suggest that at the time of accident my age was 67 years. It is false to suggest that I in active collusion with police, have got created documents and am deposing falsehood before this court by filing this false affidavit.
