

**Witness present and duly sworn on 21.08.2025**

**Cross examination by Sri.MEM Advocate for Respondent:-**

I am a graduate of BBA. I have a bank account in SBI, Kumaraswamy layout branch. Now I am not doing any job. Prior to the accident, I was a student and was not doing any job. If I get job, I can do the said job with difficulties, because I can't sit and stand for long time. It is false to suggest that in order to get compensation, though I am not suffering any difficulties or disability, I am deposing falsehood before this court.

2. My brother Saleem Khan is a RC owner of the motorcycle in which I was proceeding at the time of accident. I had DL. I do not know the width of alleged road, however, there is a divider between two roads and two heavy vehicles can move at a time. Offending vehicle dashed from behind against my motorcycle. It is true to suggest that the alleged road is a tar road. The accident occurred in front of Banashankari temple, Banashankari. It is true to suggest that there are the metro station and bus stop near the alleged incident place. It is true to suggest that the said road is a busy road. It is true to suggest that no vehicle can move at high speed in the alleged road.

3. I was proceeding extreme left side of my direction. I had been alone. It is false to suggest that I was riding the

motorcycle in a zig zag manner, thereby the accident occurred due to my negligence and not on the part of driver of offending vehicle. I was conscious and admitted in Jayanagar Orthopedic Centre. I underwent inpatient treatment for three days. I took entire treatment in the said hospital. The hospital authority did not enquire about history of my injury nor taken any statement from me. Witness voluntary states that they had taken statements from my parents. The same day my parents came to the hospital. All my relatives came to the hospital. I can produce the statements recorded by the doctors from my parents.

4. There was no impediment to lodge the complaint on the same day through my parents or my relatives. The complaint lodged after 20-25days of accident. I did not try to know about the exact date of lodging the complaint. I read the police documents. The police have recorded my statement in the police station. It is false to suggest that accident occurred due to my negligence, thereby I have not lodged the complaint on the same day. It is false to suggest that I in active collusion with owner of the offending lorry, I lodged the false complaint against the offending vehicle. It is false to suggest that I in active collusion with police, have got created police documents.

5. I did not undergo any surgery but they put only sutures. I have taken discharge summary from the hospital.

The said discharge summary took by the owner of the lorry by saying that he will settle the bill. The owner of the lorry had paid Rs.20,000/- to us. It is false to suggest that I have got created medical bills for this case. It is false to suggest that I sustained only simple injuries, in order to get compensation, I am deposing falsehood before this court.

6. It is false to suggest that though I did not undergo any inpatient treatment, in order to get compensation, have got created medical documents and am deposing falsehood before this court by filing this false affidavit.
