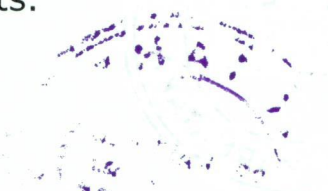

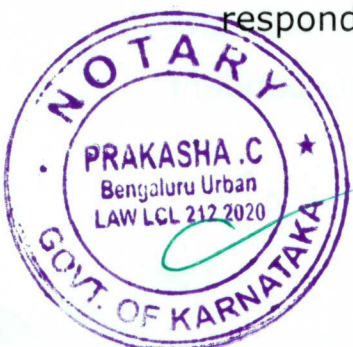
1. I submit that I am the project head of the Respondent No.1 in the above case. I know the facts of the case. Accordingly, I am swearing this affidavit.

4. I submit that the petitioners have filed their petition and the averments made in the petition which are against the respondent No.1 are all denied as false and incorrect statements.



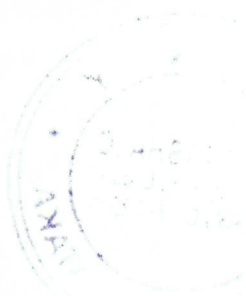
