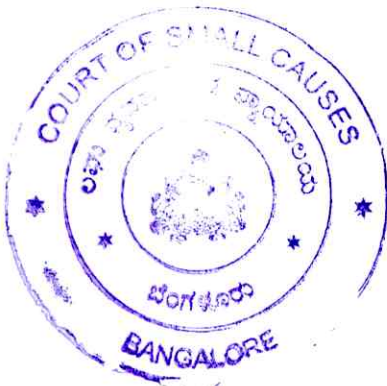

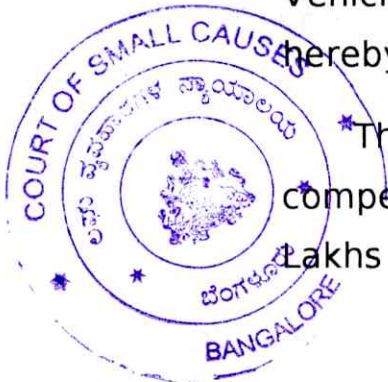

ORDER

The petition under Section 166 of Motor Vehicles Act, 1988 filed by the petitioner is hereby allowed.

* The petitioner is entitled for total compensation of **Rs.9,18,000/-** (Rupees Nine Lakhs Eighteen Thousand only) together with



interest at the rate of 6% p.a. from the date of petition till realization.

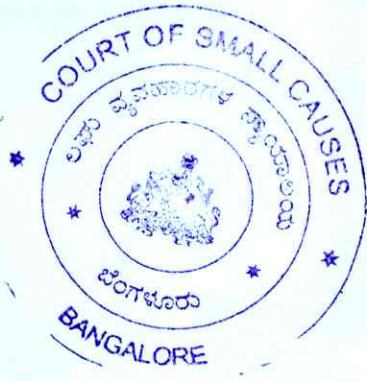
The respondents No.1 and 2 are jointly and severally liable to pay the compensation amount and 2nd respondent is hereby directed to pay the entire compensation amount together with interest within 2 months from the date of this Award.

Out of the total compensation awarded, 30% of the amount shall be invested in the form of Fixed Deposit in the name of the petitioner for a period of five years in any of the Nationalized Banks of petitioner's choice and the remaining 70% of the amount is ordered to be released in favour of the petitioner.

The Advocate fee is fixed at Rs.1,500/-.
