

**Witness present and duly sworn on 23.07.2025**

**Cross examination by Advocate for Respondent no.2:-**

Presently I am residing in Chikkegowdanapalya, Banashankari 6<sup>th</sup> Stage. I studied 2<sup>nd</sup> PUC. I do have knowledge regarding the contents stated in my chief affidavit. I can read and Kannada & English. The accident occurred on 01.05.2024 at 12.25p.m. I was proceeding from Thalagattapura to Varahasandra. I and my friend were traveling on the motorcycle. My friend Akash was riding the said motorcycle. He had DL. I have not produced DL of Akash before this court. I did not have any impediment to produce DL of Akash before this court.

2. White colour Creta car bearing no.KA-51-MN-9653 was caused the accident. It is false to suggest that my friend Akash was riding the motorcycle at high speed and he had tried to over take the car, thereby accident occurred. It is false to suggest that I did not wear the helmet, thereby I sustained head injury.

3. I was immediately went to P.M. Santhosh hospital, Kengeri and underwent treatment for one day. After accident I was not conscious. Thereafter I shifted to KIMS hospital. Where I underwent inpatient treatment for a period of 21days. I produced the documents to that effect. I was discharged from KIMS hospital on 21.05.2024. It is false to suggest that I have not incurred Rs.3,50,000/-towards medical expenses and Rs.50,000/-towards transportation and other incidental charges. I have produced documents before this court to substantiate that

I have incurred Rs.3,50,000/-towards medical expenses and Rs.50,000/-towards transportation and other incidental charges.

4. I was working in Amazon Distributor Pvt Ltd as a Sales executive nearly 1½ year. To substantiate the same, I have produced appointment letter before this court. I was getting salary of Rs.23,400/- per month. The said salary was credited to my bank account. I have produced bank statement before this court. There is no medical facilities in Amazon Distributor Pvt Ltd and I have not insured in any health insurance. It is false to suggest that I have reimbursed medical bills from Amazon Distributor Pvt Ltd. I can examine the employer of Amazon Distributor Pvt Ltd as a witness.

5. It is false to suggest that I can lead my life as I did prior to the accident. It is false to suggest that I falsely stated regarding loss of memory in para-5 of my chief affidavit. My friend Akash had lodged the complaint. It is false to suggest that in order to get compensation, I and my friend in active collision with police, have got created police documents and filed false complaint against the offending vehicle.
