

WITNESS PRESENT AND DULY SWORN ON : 10.02.2025.**Cross Examination by Sri.KSK Advocate for R2 / Insurance company :**

- 1) When I was riding Motorcycle from Hosakote towards New Tippasandra met with an accident. The place of accident is a heavy traffic area containing divider. During accident I was riding Motorcycle at 40 to 45 kmph. During accident a car was running beside my two wheeler and at a distance of 100 feet 2 cars are running.
- 2) In the place of accident there is a provision for U-turn and crossing for pedestrian. The car which caused accident came from my left side at 50 to 60 kmph. Immediately prior to accident no vehicles are running in front of my two wheeler and car.
- 3) When driver of the car made effort to turn the car in U-turn area the car came in contact with my two wheeler.
- 4) It is true to suggest that prior to turning of the car to pass in U-turn area there was opportunity for me to pass my two wheeler between car and U-turn area.

- 5) It is false to suggest that as per sketch marked at Ex.P.3 when I turned the two wheeler towards left side, my two wheeler came in contact with the car. Gear liver and left bumper of my two wheeler came in contact with the car. It is false to suggest that when I fall along with Motorcycle driver of the car came and made help to me. Public who are present in the spot helped me, then driver of the car came and helped me.
- 6) 7 to 8 persons came from ADE company gate and made help. During accident neither traffic police nor law and order police are present in the spot. It is true to suggest that as per the instruction of the public driver of the car shifted me to Review hospital, Bengaluru, wherein first aid has been provided for 25 to 30 minute.
- 7) In the Review hospital nurse asked my name, reason for the injuries and provided first aid. I have completed M.Sc (biotechnology).
- 8) I have not produced documents regarding first aid provided at Review hospital, Bengaluru. From Review hospital I have been shifted to Aryan hospital, Jnanbarathi, Bengaluru. There is a distance of 20 to 30 kms between Review hospital

and Aryan hospital. In Aryan hospital after furnishing information about reason for the injuries, treatment has been provided upto night. Aryan hospital authorities have furnished documents about treatment. When I was in Aryan hospital police never enquired me.

- 9) From Aryan hospital I have been shifted to Vydehi hospital, Bengaluru. There is a distance of 35 to 40 km between Aryan hospital and Vydehi hospital. Next day at 1.30 p.m., I have reached Vydehi hospital, Bengaluru, wherein I have been treated for 3 days. In Vydehi hospital K-wire has been fixed to my metatarsal bone.
- 10) I spent Rs.3,00,000/- for treatment. My Motorcycle bearing Reg. No.KA-07-EG-9772 having insurance coverage. It is false to suggest that driver of the car which alleged to have been caused accident borne Rs.3,00,000/- alleged to have been spent for treatment. It is false to suggest that Respondent No.1 – owner of the car never made monetary help for treatment.
- 11) Subsequent to discharge from Vydehi hospital 15 times I have taken followup treatment.

12) I have not produced documents regarding my income. It is false to suggest that as on today I am not facing any difficulties to perform my day-to-day activities / duties. It is false to suggest that my employer company reimbursed my medical expense. I will produce the evidence of my employer. Till date I have not produced medical certificate regarding my inability to perform my duties as performed prior to accident.

13) Till date I have not produced IMV Report pertaining to Car bearing Reg. No.AP-26-BH-5995. It is false to suggest that due to my negligence the alleged accident taken place, however by colluding with the police I get fabricated bogus documents against the driver of the car. It is false to suggest that above noted car is not involved in the alleged accident.

14) It is false to suggest that I have filed false Affidavit and deposed false evidence.

Cross examination by R1:

R1 absent. Hence cross examination by R1 is taken as nil.
