Witness recalled an duly sworn on 22.06.2023.

Cross-Examination by Sri KMM for accused :

It is true to suggest that, at the time of mahazar I have to summon the localites. Witness volunteers that who ever available is taken as witness. It is true to suggest that, A2 resides at Srinagara. It is true to suggest that, the panchas witnesses are not the localites of Srinagar. It is true to suggest that, A2 was working at Sagar Clinic. It is true to suggest that, in mahazar initially we have not mentioned the color of the seal. Witness volunteers that after seeing the color on same day, I have mentioned the color. It is false to suggest that, I have seized any seal on said day, I have only stated the seal and subsequently mentioned the color of the seal. I have not mentioned the measurement of the seal in the mahazar, but I have mentioned the contents. It is true to suggest that, in mahazar we have not mentioned the existence of the drainage. It is false to suggest that, I have never visited the spot and not seized any property in order to fix the Accused in have created the mahazar. It is true to suggest that, I have conducted mahazar in Sagar Clinic. It is true to suggest that, in this case application was made for Sagar Hospital. It is false to suggest that in order to fit the Accused, I have filed this case against the Accused. It is false to suggest that, Ex.P1 is also created in the police station. It is false to suggest

that, by creating the documents, I have filed false case against the Accused. It is false to suggest that, the Accused never threw the PEN Drive and Seal in to the drainage. It is false to suggest that, though there are not materials against Accused I have false case against Accused.

I have seen FIR. It is true to suggest that, names of A1 and 2 are not mentioned in FIR and complaint. We have not filed second FIR, as it was not necessary. In this case, PSI – Kiran had arrested A1 and 2 and produced them before me. I have not mentioned the same in charge sheet, but I have entered it in CD. It is true to suggest that, one Ramesh was applicant in this case and he himself had signed said application. It is true to suggest that, Adhaar Card and Voting Card enclosed to application were in his name. It is true to suggest that, I have conducted mahazar on 23.10.2015 at the house of A2 situated in Shrinagar. It is true to suggest that, witnesses were from Adugodi and DJ Halli. I do not know if the distance between the spot and their house is about 40 kms. Witness volunteers we had taken said witnesses from our police station itself. It is true to suggest that, I have not mentioned description of seized seal. It is false to suggest that, I had intentionally left blank the place of color of seal in mahazar and later I have mentioned it. It is true to suggest that, the color of related words are different in mahazar. It is false to suggest that, I have not visited said house, I have not

conducted any mahazar and I have created said mahazar at police station itself. It is false to suggest that, I have not obtained signatures of witnesses.

It is true to suggest that, on 24.10.2015 I have conducted mahazar at Sagar Hospital. It is true to suggest that, as per work letter collected by me, A2 was working in Sagar Clinic. It is true to suggest that, bills produced by me belongs to Sagar Hospital. Witness volunteers A2 himself has created it. I have enquired about Computer Operators and other employees of Sagar Hospital. I have not seized the computers and data of Sagar Hospital as it was not necessary. It is true to suggest that, there is separate wing of Sagar Hospital and Sagar Clinic. It is true to suggest that, Sagar Hospital is situated at Tilaknagar, Jayanagar and Sagar Clinic is situated at Ring Road, Banshankari. It is true to suggest that, there will be inpatients in Sagar Hospital and there will be only out patients in Sagar Clinic. It is false to suggest that, for said reason, A2 has not created any bills or other documents and I have created above mahazar to fix him. It is false to suggest that, I have obtained signatures of witnesses of mahazar on blank papers. It is false to suggest that, I have created mahazar at police station itself.
