**Committal Order U/s.209 of Cr.P.C**

This is a charge sheet filed by the PI, Chandra Layout Police Station for the

offences punishable U/Ss.376, 376(2)(n),354, 323, 406, 504, 506 read with Section 34 of IPC.

The court perused the charge sheet and taken cognizance for the said offences and registered the criminal case in Reg.No.III and issued summons to the accused No.2 to 4. Accused No.1 was in JC.

The accused No.1 was released on bail. Accused No.3 and 4 appeared through their council and released on bail. The charge sheet copy is furnished to the accused No.1, 3 and 4 as per Sec.207 of Cr.P.C.

Heard both the side and the offence punishable U/Ss.376, 376(2)(n), 354, 323, 406, 504, 506 read with Section 34 of IPC is exclusively triable by Hon'ble Prl. City Civil and Sessions Judge, Bengaluru city. Hence, court proceed to pass the following:

The accused No.1, 3 and 4 are hereby directed to appear before Hon'ble Prl. City Civil and Sessions Judge, Bengaluru city after receipt of summons.
