**ORDER BELOW EXH.04**

This is an application to grant interim anticipatory bail to the applicant/accused namely Hemendra Ravindra Lal apprehending arrest in Crime No. 103 of 2023 registered at Deccan Police Station, on 29.06.2023 for offences punishable under sections 143,147,149,323,387,427, 452, 504, 506 of the Indian Penal Code.

2. Perused the application, copy of FIR and documents produced on record by the accused.

3. Learned advocate for accused argued that the name of the present accused is absent in the FIR. The Hon'ble High Court granted interim anticipatory bail to other accused, whose names are mentioned in the FIR, in this crime by order dated 07.09.2023 in Anticipatory Bail Application No. 2499/2023. Thus, he submitted that on the ground of parity, similar protection should be granted to the accused. He also submitted that the accused received notice dated 28.10.2023 under section 41(1) of Cr. P.C. and therefore, he apprehends arrest in above said crime.

4. In view of above said arguments that name of the accused is absent in the FIR and particularly on the ground of

parity, interim anticipatory bail can be granted to the accused as said order can be modified while deciding the bail application on merits. Hence, following order is passed.

**ORDER**

1. Application is allowed and interim anticipatory bail is granted to accused till filing of reply.
2. In the event of arrest of accused in Crime No. 103 of 2023 registered at Deccan Police Station, for offences punishable under sections 143,147,149,323,387,427, 452, 504, 506 of the Indian Penal Code he be released on bail on executing PR Bond of Rs.30,000/- (Rs. Thirty Thousand only ) with one or two solvent sureties for the like amount.
3. The applicant shall cooperate with the investigation and report to Deccan police station, Pune on every Saturday from 10.00 a.m. to 1.00 p.m. till further orders.
4. The accused is directed not to threaten or tamper any of the prosecution witnesses and further investigation.
5. The accused is directed not to leave India without prior permission of the Court.
6. Inform the concerned police station accordingly.
