Examination in Chief by Sr. APP:

From 2013 to 2019 I have served as HC in Soladevanalli police station. On 31.01.2016 I reported to afternoon duty at 2.00 PM to said PS. SHO of said PS deputed myself and CW32 to first beat duty at Chikkasandra, AGB layout, Janapriya Apartment, Saphthagiri College, Acharya College, Achutanagara. At about 7.45 PM, when we were on petrolling at Achutanagar, we received call from our PS that some quarrel is going on near Saphthagiri College. We reached said college in 15 minutes and found that there was tussle of nearly 300-400 persons. Hence we immediately called CW50 to arrange more men at the spot to control the mob. At that time our Peenya Hoysala Official , Traffic Constable of Jalahalli were present and we found that mob of college students were manhandling two African National Students. We rescued

said foreign student from the mob and sent them to Kirloskar Layout. Thereafter we found that a car was set on fire at the spot. We tried to put off the fire with the help of local shop keepers, by that time PI of Peenya PS came to the spot and secured fire extinction officials. On enquiry with public, they informed us that a car of African students caused accident and caused death of a muslim lady and injury to her husband. Hence the aforesaid mob attacked said foreign students. At that time an election canvassing was also going on at the spot. Thereafter we received information that another car was set on fire at Ganapathinagar and we went to said spot. By that time our ACP Ashwathnarayan and Crime staff had reached the spot and we put of the fire. Thereafter the dead body of muslim lady who died in accident was kept in Sapthagiri hospital and a mob had gathered near said hospital also. Thereafter we were deputed for duty to said hospital for maintaining peace till 12.30 AM. I had seen A5, 6, 8 and 9 causing said tussle and mischief. I can identify said accused persons if shown to me. Further the mob was outraging modesty by pulling and pushing both students.

It is true to suggest that A1 to 4 and 7 were also present at the spot and they caused above mischief. I can identify said accused persons if shown to me.

Sri HAG for AMR and Sri MUS for A12 and A19 prays time. Counsel for other accused absent. No grounds. Cross examination of witness taken as nil.
