After the death of my father, myself and my sisters acquired the said property as per the Will executed by my father on 09.12.1998. My father has executed the Will in favor of me, my sister Jayalakshmi, Chikkagowramma and Kiran and Chandrashekar the sons of Jayalakshmi. We were collecting the rent in respect of said buildings. The accused Narendra and Prasanna came near the building and made galata on 01.08.2011 at 04.00p.m. The

accused informed that, Ramaiah has executed Gift deed in their favor and they are entitled to collect rent and that rent should be paid to them. The tenants informed us that, the accused had gone to them and showed the gift deed and ask them to pay the rents and to vacate the premises and threatened them. Later we went to Office of the Sub-registrar, Bommanahalli and got the copy of the Gift deed. We came to know that, accused have got created false Gift deed. The Gift deed was of the year 2010. Later we went to police station and lodged complaint stating that, accused have created forged documents. Now I see the complaint and same is marked as Ex.P.1 and signature of the witness is marked as Ex.P.1(a). Along with the complaint, I furnished the copies of the documents. The certified copies of the Will is marked as Ex.P.2, True copy of the Rent agreement is marked as Ex.P.3, Khata certificate standing in my name is marked as Ex.P.4, Khata extract is marked as Ex.P.5., property tax receipt is marked as Ex.P.6, Khata certificate standing in the name of A.R.Kiran alias Babu and A.R.Chandrashekar is marked as Ex.P.7., Khata extract is marked as Ex.P.8, Property tax receipt is marked as Ex.P.9, Death certificate of Ramaiah alias Doddannaiah is marked as Ex.P.10., certified copy of the Gift
