Examination in Chief by Sri BSL:-

Evidence Before Charge u/sec. 244 of CRPC.

I married Prasad Shivashankar on 17.11.2016. Accused is younger brother of my husband. After marriage my husband and my in-laws started harassing me saying that I am not good looking and I have not brought dowry from my parents house. For such harassment I had to leave my matrimonial house on 09.03.2017 night. Thereafter I went back to Chennai, which is native place of my parents. Thereafter I left job of Chennai and came back to Bengaluru. I started residing in area near by to house of my husband. Thereafter I joined a job near said house, which was

situated near my house and house of Accused. during said job my father in law used to come to my office under influence of alcohol and he was abusing me. For said reason I had to leave that job and I left said house. Further due to said harassment I filed a case against my husband and in-laws u/sec. 498A of IPC. MY evidence was recorded in said case in the month of August 2019. Thereafter on 24.08.2019 I posted a general message in facebook without mentioning anybodies name in my facebook account by name "simhikhamihikha". Thereafter the Accused created a fake facebook account my name Jackk Sparrow and he liked my aforesaid post and he shared my post to his account. I was curious to know said person. I thanked him for sharing my post and thereafter he started conversation with me, by mocking me in between. Thereafter when ever I used to post any messages in my facebook account he started harassing me and replying with vulgar language address me as slut, bitch and prostitute.

Further he started to discuss about my case in all social media accounts. Thereafter I changed my accounts name in kannada language as "simhikhamihikha". Thereafter it became easy for me to create fake facebook account in my name. The Accused started posting messages with said fake account in my name saying that

I am a call girl and anybody can call me for satisfaction. Thereafter I unlocked account of Accused in whatsapp. Then I gave reply to account of Accused by name james sparrow which was seen by Accused and I got a counter reply for my whatsapp status in facebook face ID of james sparrow. Thereby I came to know that Accused himself has created aforesaid fake account and he is sending abusive and vulgar messages to my post and he is also sending obscene messages in my name by using fake facebook account created by him. Further Accused was sending obscene gestures in facebook by way of posts and he was showing middle finger image. When I approached Cyber Crime police stations, they asked me to approach some other police stations, but no case was registered in that regard.

Further Accused posted messages in facebook saying that I do multiple affairs for the sake of money, my parents are thieves and even they do money extortion. Further he posted messages saying that I don't have good education and he called my Advocate mother as "Nalayak and Kali Coat Vali". He further stated that my mother bought her coat from Barma Bazar and sitting in court hall. He also posted messages in facebook saying that my self tweet and re-tweet is like masturbating for self satisfying. Further he posted a image on facebook by

saying “fuck you bitch”. Thereafter Accused had uploaded my previous photo with a person whom I knew earlier in his whatsapp status. Further he laughed at me for not taking my complaint by Cyber Crime police stations.

Thereafter recently I had approached Cyber Crime police station, HSR Layout, Blore, who received my complaint. They called Accused to their police station and on enquiry Accused admitted that he is behind all aforesaid misdeeds. Further revealed that he is doing it on the grudge because I had given evidence against him. In spite of it said police did not register case against him, they just issued acknowledgment with regard to about say of Accused. Further after coming out of said police station Accused made me bad gesture and hit me with his bike. The Accused deactivated jacksparrow and jamesparrow after tacking it with police officials. The Accused has defamed me in the eyes of public, my friend and relatives by aforesaid acts. I have produced printouts of messages posted by Accused in facebook and whatsapp. I have also produced copies of complaint lodged by me before other police.

Now I see certified copy of complaint and FIR lodged by me before Bommanahalli PS under Cr. No. 427/2017,

same are marked as Ex.P1 and 2. Now I see my deposition in CC No. 3173/2018, same is marked as Ex.P3.
