**Suit claim:** Suit was filed on 16/09/2025 by the plaintiff and prays to pass Judgment and Decree as follows :

- a. Direct the Defendants jointly and severally to pay Rs.4,45,349/- (Rupees four Lakhs forty five thousand three hundred and forty nine only) to the Plaintiff.
- b. Direct the defendants jointly and severally to pay future interest on Rs.4,45,349/- (Rupees four Lakhs forty five thousand three hundred and forty nine only) @ 24% P.A. from the date of filing of the suit till the date of re-payment to the Plaintiff.
- c. The cost of suit and such other relief's.

This suit coming on this day for final disposal before **Sri. ANAND T. CHAVAN, LXXXIV Addl. City Civil & Sessions Judge, (Commercial Court), Bengaluru City** in the presence of Sri. Mohumed Sadiqh. B. A, Advocate for the Plaintiff; Sri. Devaraj. C. H & Associates, Advocates for the Defendants.

**It is ordered and decreed that the suit of the plaintiff is decreed in part with costs.**

**It is further ordered and decreed that Defendants are jointly and severally liable to pay sum of Rs.4,45,349/- (Rupees four Lakhs forty five thousand three hundred and forty nine only) to plaintiff along with interest at the rate of 18% per annum from the date of suit till realization.**

And that a sum of **Rs.39,228/-** to be paid by the Defendants to the Plaintiff on account of the costs of this suit.
