SUIT CLAIM: Suit was filed on 11/12/2025 by the plaintiff and prays to pass judgment and decree in favour of plaintiff and as against the defendants :

- a. For the payment of a sum of **Rs.6,24,314.49ps. (Rupees Six Lakh Twenty Four Thousand Three Hundred Fourteen and Forty Nine Paise Only)** being the suit claim along with further compound interest @ 19.5% p.a. as per the provisions of the Micro, Small and Medium Enterprises Development Act, 2006 from the date of the suit till the date of the realization,
- b. To grant cost of the proceedings incurred by the Plaintiff; and
- c. To grant such other reliefs.

Suit of the plaintiff is decreed with costs.**

It is further ordered and decreed that the defendant is liable to pay to the plaintiff a sum of Rs.6,24,314.49ps (Rupees Six Lakh Twenty Four Thousand Three Hundred Fourteen and Forty Nine Paise Only) with interest at 19.5% p.a. as per MSME Act from the date of suit till realization.

And that a sum of **Rs.40,870/-** to be paid by the defendant to the Plaintiff on account of the costs of this suit.
