1. Whether the Plaintiff proves that the Defendants are jointly and severally liable to pay a sum of Rs. 3,98,34,766/- ?
2. Whether the Plaintiff proves that the Defendants are liable to pay the interest at that rate of 18% from the date of the suit till the date of payment ?
3. Whether the Defendant No.3 proves that the Plaintiff to escape the legal liability made this Defendant No.3 as party to this suit ?

4. Whether the Defendant No.3 proves that Mr. Anurag threatened him with dire consequences and forcibly obtained confession letter from him ?
5. Whether the Defendant No.15 proves that Plaintiff has deliberately added this Defendant to this suit, solely with intention to Pre-empting this Defendant from filing original suit against the Plaintiff for recovery of due a sum of Rs, 75,25,770/- together with interest ?
6. Whether the Defendant No.15 proves that the Plaintiff is liable to pay sum of Rs. 75,25770 with interest at the rate of 17% per annum from the date of the invoice till the date of payment ?
7. Whether the Defendant No.14 proves that Plaintiff has deliberately added this Defendant to this suit, solely with intention to Pre-empting this Defendant from filing original suit against the Plaintiff for recovery of due a sum of Rs, 32,80,000/- together with interest ?
8. Whether the Defendant No.14 proves that the Plaintiff is liable to pay sum of Rs. 32,80,000/- with interest at the rate of 17% per annum from the date of the invoice till the date of payment ?
9. Whether the Defendant No.26 proves that Plaintiff has deliberately added this Defendant to this suit, solely with intention to Pre-empting this Defendant from filing original suit against the Plaintiff for recovery of due a sum of Rs, 17,68,370/- together with interest ?

10. Whether the Defendant No.26 proves that the Plaintiff is liable to pay sum of Rs. 17,68,370/- with interest at the rate of 17% per annum from the date of the invoice till the date of payment ?
11. Whether the Defendant No.27 proves that the plaint which does not contain any allegations of disclosure of cause of action and alleges no preivity of contract between the Plaintiff and 27th Defendant is liable to be rejected ?
12. Whether the Defendant No.27 proves that there is a total mis-joinder of cause of action ?
13. Whether the Defendants prove that the suit is not maintainable?
14. Whether the Defendant No.14, 15 and 26 proves that the suit of the Plaintiff is premature one ?
15. Whether the Defendant No. 14,15 and 26 are entitled the relief claimed in counter claim ?
16. Whether the Plaintiff is entitled for the reliefs as prayed for ?
17. What Order or decree ?
