**Examination in chief by the Learned PP on
behalf of the state;-**

I know the accused No.1 and 2. I was running hotel in the building of one Kashinath at Hipparga cross. There was a highway road in front of my hotel. I was service break fast, tea, water bottle, cold drinks and glasses in my hotel. In the year 2021 at about 8:00 to 9:00pm three members were came to my

hotel out of them one person purchased water bottle from my hotel. Witness identified accused No.2 who is present before the court.

At this juncture, the learned PP for the state requested to treat the witness as partly hostile and sought permission to cross examine him. Heard and perused. Satisfied. The present witness is treated as partly hostile and thereby, it is permitted to conduct the cross examination.

Cross examination by PP :-

It is not true to suggest that after purchase water bottle from my hotel the accused No.1 and 2 and deceased were drunken the alcohol in front of my hotel which was brought by them. It is true to suggest that after 25 to 28 days police took the accused No.1 and 2 before my hotel and enquired me by the police I stated the accused No.1 and 2 and

deceased were drunken in front of my hotel. It is true to suggest that I came to know the accused No.1 and 2 have committed murder of the deceased when the police took the accused No.1 and 2 before my hotel. It is true to suggest that I have stated before the police as read over now.

Cross Examination by Sri. S.K.R., Advocate
on behalf of accused No.1 and 2.

There was no written rent agreement between me and Kashinath in respect to running the hotel. I was running the hotel by 10 to 12 years. Since from 5 years my hotel situated towards Mumbai road at Hipparga village. I have not obtained licence to running the hotel from the Gram Panchayat. There was no workers in my hotel as on the date of incident. Witness voluntarily deposed my brother was worker in my hotel and my hotel opened by 7:00am in morning till 9:00pm. It is not true to suggest that when accused No.2 came to my hotel there was no

electricity power in my hotel as say by me in my chief examination. Witness voluntarily deposed that there was a candle was on in my hotel. It is not true to suggest that accused No.2 was not came to my hotel as on alleged date. It is not true to suggest that accused No.2 was not came to my hotel and I am deposing false evidence. On 21.01.2021 at about 9:00pm there was no customers were came to my hotel except one person. I do not know when police petrolling at Hipparga cross. There was a two Dhaba exist at Vaddankera cross for away 1 km between my hotel and two Dhaba from my hotel. It is not true to suggest that I have no hotel at the time of alleged date. It is not true to suggest that accused No.2 was not came to my hotel and purchased one water bottle. Witness voluntarily deposed that one person came and purchased water bottle from my hotel. It is not true to suggest that after 25 days the police took the accused No.1 and 2 before my hotel and I was

identified the accused No.1 and 2 who were came to my hotel 25 days back and purchased water bottle. It is not true to suggest that I am deposing false evidence as deceased Revansidda was accompanied with the accused No.1 and 2 as on the alleged date. It is not true to suggest that I am deposing false evidence as I came to know from the police the accused No.1 and 2 were committed murder of the deceased and I stated before the police as per the cross examination by prosecution. It is not true to suggest that I am deposing false evidence in my chief examination.
