CHARGE

District and Sessions Judge, Belagavi do hereby charge you:

1. Maheshwari @ Shruti W/o Kumar
Honamani, Age: 28 years,
Occ: Household & Bouncer,
R/o: Honaga, Tq: Belagavi,
N/At Plot No.1120, Kuvempu Nagar,
Chikkubhag, Belagavi.
2. Baban Narayan Lad,
Age: 60 years, Occ: Business,

3. Jayalakshmi Baban Lad,
Age: 55 years, Occ: Household,

as follows:

That on 07.10.2023 at about 06.30 p.m., and 07.05 p.m., at Kuvempu Nagar, Belagavi within the jurisdiction of APMC PS., you the accused No.1 to 5 were being the members of an unlawful assembly, in prosecution of the common object of that assembly, which you the accused persons abused and assaulted the CW.1 Shruti Ramesh Harijan, CW.4 Ramesh Yamanappa Harijan, CW.5 Vijayanti Ramu Kadam, CW.6 Bhavana Ramu Kadam and CW.7 Anjali Santosh Simpi and committing some criminal acts against them and thereby you have committed an offence punishable U/sec.143 of IPC within my cognizance.

Secondly, on the aforesaid date, time and place, you the accused No.1 to 5 were being the members of unlawful assembly, in prosecution of the common object of that assembly, which you accused persons abused and assaulted

the CW.1, CW.4 to CW.7 and to commit the offence and thereby you have committed rioting an offence punishable U/sec.147 IPC within my cognizance.

Thirdly, on the aforesaid date, time and place, you the accused No.1 to 5 were being the members of an unlawful assembly, in prosecution of the common object of that assembly, you have intentionally insulted CW.1, CW.4 to CW.7 abusing them in filthy language and thereby gave provocation to CW.1, CW.4 to CW.7 knowing it to be likely that such provocation would cause them to break the public peace and thereby you have committed the offence punishable U/Sec.504 R/w Sec.149 of IPC within my cognizance.

Fourthly, on the aforesaid date, time and place, you the accused No.1 to 5, were being the members of an unlawful assembly, in prosecution of the common object of that assembly, which you accused persons voluntarily caused hurt to CW.1 and CW.4 to CW.7, you the accused No.4 and 5 assaulted CW.1, CW.4 to CW.7 with hands on their bodies, causing hurt and bodily pain to them and thereby you have committed an offence punishable U/sec.323 R/w Sec.149 IPC within my cognizance.

Fifthly, on the aforesaid date, time and place, you the accused No.1 to 5 were being the members of an unlawful

assembly, in prosecution of the common object of that assembly, you accused No.5 jumped over the gate and trespassed inside and assaulted CW.4 and thereby you committed an offence punishable U/sec.448 R/w Sec.149 of IPC within my cognizance.

Sixthly, on aforesaid date, time and place, you the accused No.1 to 5 were being the members of an unlawful assembly, in prosecution of the common object of that assembly, you have committed criminal intimidation by posing life threat to CW.1, CW.4 to CW.7 and thereby you have committed the offence punishable U/Sec.506 R/w Sec.149 of IPC and within my cognizance.

Seventhly, on the aforesaid date, time and place, you the accused No.1 knowing full well that CW.1, CW.4 to CW.7 belongs to Scheduled Caste community intentionally you accused persons insulted them with an intent to humiliate them in a place within public view and thereby you have committed an offence punishable U/sec.3(1)(r) of SC/ST (POA) Amendment Act 2015 within my cognizance.

Eighthly, on the aforesaid date, time and place, you the accused No.1 knowing full well that CW.1, CW.4 to CW.7 belongs to schedule caste abused them by taking the name of their caste in a place within a public view and thereby you

have committed an offence punishable U/sec.3(1)(s) of SC/ST (POA) Amendment Act 2015 within my cognizance.

Lastly, on the aforesaid date, time and place, you the accused No.1 committed the offences punishable U/sec.143, 147, 323. 448, 504 and 506 R/w Sec.149 of IPC against CW.1, CW.4 to CW.7, that you knowing full well that, CW.1, CW.4 to CW.7 belongs to Scheduled Caste and thereby you have committed an offence punishable U/sec.3(2)(va) of SC/ST (POA) Amendment Act 2015 within my cognizance.

I hereby direct that you be tried by me on the above said charges.
