CHARGE

I Sri. Chennappa Gouda, B.A., LL.B.(Hons), III Addl.
District and Sessions Judge, Belagavi do hereby charge
you:

1. Vinod Shivamoggi @ Maggeppa Halemani,
Age: 24 years,
R/o: Aladakatti KM, Tq: Saundatti,
Dist: Belagavi.
3. Akshay Basavaraj Sanagoudar,
Age: 24 years,
R/o: Aladakatti KM, Tq: Saundatti,
Dist: Belagavi.

as follows:

1. That you accused No.1 and 3 on 16.01.2021 in front of
the house of complainant Fakirappa Halagali in furtherance of
your common intention to assault and insult CW.4 Pundalik
Phakirappa Halagali caused hurt to CW.4 Pundalik by
assaulting him by hands and you thereby committed an

offence punishable U/sec.323 R/w 34 IPC within my cognizance.

2. That you accused No. 1 and 3 on the above said date, time and place with the above common intention voluntarily caused hurt to CW.4 Pundalik Phakirappa Halagali by assault him with stone and you thereby committed an offence punishable U/sec.324 R/w 34 IPC within my cognizance.

3. That you accused No. 1 and 3 on the above said date, time and place with the above common intention wrongfully restrained CW.4 Pundalik Phakirappa Halagali and you thereby committed an offence punishable U/sec.341 R/w 34 IPC within my cognizance.

4. That you accused No.1 and 3 on the above said date, time and place with above common intention abused the CW.4 Pundalik in filthy language stating that “ಹಡಸು ಬಾಡ್ಯಾ ಸೊಳೆ ಮಗನ ನಿನಗ ಸೊಕ್ಕ ಬಾಳ ಆಗೈತಿ” and you thereby gave the CW.4 Pundalik Phakirappa Halagali provocation intending that, such provocation will cause him to break the public peace and you thereby committed an offence punishable U/sec.504 R/w 34 IPC within my cognizance.

5. That you accused No.1 and 3 on the above said date, time and place with the above common intention gave life threat to CW.4 Pundalik Phakirappa Halagali and you thereby

committed an offence punishable U/sec.506 R/w 34 IPC within my cognizance.

6. That you accused No.1 and 3 on the above said date, time and place knowing full well that CW.4 Pundalik Phakirappa Halagali belongs to SC/ST community intentionally insulted him with an intent to humiliate the latter in a place within public view and you thereby committed an offence punishable U/sec.3(1)(r) of SC/ST (POA) Act 1989 within my cognizance.

7. That you accused No. 1 and 3 on the above said date, time and place knowing full well that CW.4 Pundalik Phakirappa Halagali belongs to schedule caste abused him by taking the name of his caste in a place within a public view and you thereby committed an offence punishable U/sec.3(1) (s) of SC/ST (POA) Act 1989 within my cognizance.

I hereby direct that you be tried by me on the above said charges.
