as follows:

CHARGE

That on 23.05.2024 at about 5.30 p.m. in the open ground of Government Higher Primary Marathi school near Hajarat Baba Darga in Alavan Galli of Shahapur, Belagavi within the limits of Shahapur PS, you accused No.1 to 9 formed an unlawful assembly, with an intention to commit crime against the son of complainant-CW1 and CW10 with

regard to playing of cricket in the school ground and thereby committed an offence punishable under Section 143 read with Section 149 of IPC and within the cognizance of this court.

Secondly, on the above said date, time and place, you accused No.1 to 9, being the members of unlawful assembly, in furtherance of your common object, picked up quarrel with CW9 and CW10 and committed rioting against them and thereby committed an offence punishable under Section 147 read with Section 149 of IPC and within the cognizance of this court.

Thirdly, on the above said date, time and place, you accused No.1 to 9, being the members of unlawful assembly, in furtherance of your common object, picked up quarrel CW9 and CW10 and you were armed with deadly weapons like stump, sword and club in your hands and thereby committed an offence punishable under Section 148 read with Section 149 of IPC and within the cognizance of this court.

Fourthly, on the above said date, time and place, you accused No.1 to 9, being the members of unlawful assembly, in furtherance of your common object to commit crime, picked up quarrel with the CW9 and CW10 and you accused No.4 and 8 voluntarily assaulted CW9 and CW10 with hands, causing injuries to them and thereby you have committed an offence punishable under Section 323 read with Section 149 of IPC and within the cognizance of this court.

Fifthly, on the above said date, time and place, you accused No.1 to 9, being the members of unlawful assembly, in furtherance of your common object to commit crime, picked up quarrel with the CW9 and CW10 and you accused No.4 voluntarily assaulted CW9 and CW10 on their body with stump, causing simple injuries to them and thereby you have committed an offence punishable under Section 324 read with Section 149 of IPC and within the cognizance of this court.

Sixthly, on the above said date, time and place, you accused No.1 to 9, being the members of unlawful assembly, in furtherance of your common object, of which, you Abdulmutalif Salauddin Toragal child in conflicting with law with an intention to commit murder of CW5, when she had been to rescue her son CW9, blow the sword and pelted stones and caused injury and thus, you all the accused, knowing that causing such injury on the vital part of body of any person, is likely to cause her death and you would have been guilty of murder, attempted to murder CW5 and thereby you have committed an offence punishable under Section 307 read with Section 149 of IPC and within the cognizance of this court.

Seventhly, on the above said date, time and place, you accused No.1 to 9, being the members of unlawful assembly, in furtherance of your common object to commit crime, picked up quarrel with the CW9 and CW10 and you accused No.1 pulled CW4 with an intention to outraged her modesty and thereby you have committed an offence

punishable under Section 354 read with Section 149 of IPC and within the cognizance of this court.

Eighthly, on the above said date, time and place, you accused No.1 to 9, being the members of unlawful assembly, in furtherance of your common object to commit crime, picked up quarrel with the CW4 and CW5, abused them in filthy language, with an intention to insult them and to provoke them to break the public peace or to commit any offence and thereby you have committed an offence punishable under Section 504 read with Section 149 of IPC and within the cognizance of this court.

Lastly, on the above said date, time and place, you accused No.1 to 9, being the members of unlawful assembly, in furtherance of your common object, picked up quarrel with CW4 and CW5, posed threat to their life with intent to cause alarm to them and thereby you have committed an offence punishable under Section 506 read with Section 149 of IPC and within the cognizance of this court.

And I hereby direct that you be tried by this court on the above said charges.
