CHARGE

That on 23.05.2024 at about 6.00 p.m. in front of house of complainant-CW1, near Hajarat Lalu Sha Baba Darga, Alavana Galli within the limits of Shahapur PS, you accused No.2 to 12 along with deceased accused No.1 and children in conflict with law formed an unlawful assembly, with an intention to commit crime against the complainant-CW1, 4, 10 and 11 with regard to previous enmity and thereby committed an offence punishable under Section 143 read with Section 149 of IPC and within the cognizance of this court.

Secondly, on the above said date, time and place, you you accused No.2 to 12 along with deceased accused No.1 and children in conflict with law, being the members of unlawful assembly, in furtherance of your common object, picked up quarrel with CW1, 4, 10 and 11 and committed rioting against them and thereby committed an offence punishable under Section 147 read with Section 149 of IPC and within the cognizance of this court.

Thirdly, on the above said date, time and place, you you accused No.2 to 12 along with deceased accused No.1 and children in

conflict with law, being the members of unlawful assembly, in furtherance of your common object, picked up quarrel CW1, 4, 10 and 11, were armed with deadly weapons like stump, bat and stones in your hands and thereby committed an offence punishable under Section 148 read with Section 149 of IPC and within the cognizance of this court.

Fourthly, on the above said date, time and place, you you accused No.2 to 12 along with deceased accused No.1 and children in conflict with law, being the members of unlawful assembly, in furtherance of your common object, of which, you accused No.1 with an intention to commit murder of CW10, assaulted him with bat on his head, you accused No.3 assaulted him with stump, causing injury and thus, you all the accused, knowing that causing such injury on the vital part of body of any person, is likely to cause his death and you would have been guilty of murder, attempted to murder of CW10 and thereby you have committed an offence punishable under Section 307 read with Section 149 of IPC and within the cognizance of this court.

Fifthly, on the above said date, time and place, you you accused No.2 to 12 along with deceased accused No.1 and children in conflict with law, being the members of unlawful assembly, in furtherance of your common object to commit crime, picked up quarrel with the CW1, 4, 10 and 11 and you accused No.3 voluntarily causing simple hurt by pelting stones at CW1, 4 and 11 and thereby you have

committed an offence punishable under Section 324 read with Section 149 of IPC and within the cognizance of this court.

Sixthly, on the above said date, time and place, you you accused No.2 to 12 along with deceased accused No.1 and children in conflict with law, in furtherance of your common object to commit crime, picked up quarrel with the CW1, 4, 10 and 11 and you accused No.1 pulling hands and clothes of CW4 and outraged her modesty and thereby you have committed an offence punishable under Section 354 read with Section 149 of IPC and within the cognizance of this court.

Seventhly, on the above said date, time and place, you you accused No.2 to 12 along with deceased accused No.1 and children in conflict with law, being the members of unlawful assembly, in furtherance of your common object to commit crime, picked up quarrel with the CW1, 4, 10 and 11, abused them in filthy language, with an intention to insult them and to provoke them to break the public peace or to commit any offence and thereby you have committed an offence punishable under Section 504 read with Section 149 of IPC and within the cognizance of this court.

Lastly, on the above said date, time and place, you you accused No.2 to 12 along with deceased accused No.1 and children in conflict with law, being the members of unlawful assembly, in furtherance of your common object, picked up quarrel with CW1, 4, 10 and 11,

posed threat to their life with intent to cause alarm to them and thereby you have committed an offence punishable under Section 506 read with Section 149 of IPC and within the cognizance of this court.

And I hereby direct that you be tried by this court on the above said charges.
