1. Shrinath Bhimappa Kambali,
Age: 30 years, Occ: Agriculture,

as follows:

That on 12.02.2022 at 10.40 p.m in front of the complainant house at Jalikatti village, within the jurisdiction of Ramadurg PS., you the accused No.1 to 6 were being the members of an unlawful assembly, in prosecution of the common object of that assembly, which you accused persons abused and assaulted the CW.1 Arjun Ramappa Huligoppa and CW.4 Sanvakka Ramappa Huligoppa and thereby you have committed an offence punishable U/sec.143 of IPC within my cognizance.

Secondly, on the aforesaid date, time and place, you the accused No.1 to 6 were being the members of unlawful assembly, in prosecution of the common object of that assembly, which you accused persons abused and assaulted the CW.1 and CW.4 and to commit the offence thereby you have committed rioting an offence punishable U/sec.147 of IPC within my cognizance.

Thirdly, on the aforesaid date, time and place, you the accused No.1 to 6 were being the members of an unlawful assembly, in prosecution of the common object of that

assembly, which you accused No.2 committed rioting with deadly weapon namely Stick (ಬಡಗಿ) and thereby you have committed an offence punishable U/sec.148 of IPC within my cognizance.

Fourthly, on the aforesaid date, time and place, you the accused No.1 to 6 were being the members of an unlawful assembly, in prosecution of the common object of that assembly, which you accused No.1, 3 to 6 voluntarily caused hurt to CW.1 and assaulted with hands on his body, causing hurt and bodily pain to him and thereby you have committed an offence punishable U/sec.323 R/w Sec.149 of IPC within my cognizance.

Fifthly, on the aforesaid date, time and place, you the accused No.1 to 6 were being the members of an unlawful assembly, in prosecution of the common object of that assembly, which you accused No.2 voluntarily caused hurt to CW.1 and CW.4 and assaulted with stick on their bodies, causing simple injuries to them and thereby you have committed an offence punishable U/sec.324 R/w Sec.149 of IPC within my cognizance.

Sixthly, on the aforesaid date, time and place, you the accused No.1 to 6 were being the members of an unlawful assembly, in prosecution of the common object of that

assembly, you accused No.1 intentionally insulted CW.1 abusing him in filthy by stating that “ನಿಮಗೆ ಬಹಳ ಸೊಕ್ಕು ಬಂದಿದೆ ನಮ್ಮ ಹೆಣ್ಣು ಮಕ್ಕಳ ಮೇಲೆ ಕೆಟ್ಟ ದೃಷ್ಟಿ ಹಾಕುತ್ತಿರಿ ಬೋಸಡಿ ಮಕ್ಕಳರ್ಯಾ, ವಾಲ್ಮೀಕಿ ಸೂಳೆ ಮಕ್ಕಳರ್ಯಾ” and thereby gave provocation to CW.1 knowing it to be likely that such provocation would cause him to break the public peace and you thereby have committed an offence punishable U/sec.504 R/w Sec.149 of IPC within my cognizance.

Seventhly, on the aforesaid date, time and place, you the accused No.1 to 6 were being the members of an unlawful assembly, in prosecution of the common object of that assembly, you have committed criminal intimidation by posing life threat to CW.1 by stating that “ಇದೊಂದು ಸಲ ಉಳಕೊಂಡಿ ಮಗನೇ, ಇನ್ನೊಮ್ಮೆ ಸಿಕ್ಕರೆ ನಿನಗೆ ಜೀವ ಸಹಿತ ಬಿಡುವುದಿಲ್ಲ” and thereby you have committed the offence punishable U/Sec.506 R/w Sec.149 of IPC and within my cognizance.

Eighthly, on the aforesaid date, time and place, you the accused No.1 to 6 knowing full well that CW.1 and CW.4 belongs to Scheduled Tribe community intentionally you accused persons insulted them with an intent to humiliate them in a place within public view and you thereby committed an offence punishable U/sec.3(1)(r) of SC/ST (POA) Amendment Act 2015 within my cognizance.

Ninethly, on the aforesaid date, time and place, you the accused No.1 to 6 knowing full well that CW.1 and CW.4 belongs to schedule Tribe abused them by taking the name of their caste in a place within a public view and you thereby committed an offence punishable U/sec.3(1)(s) of SC/ST (POA) Amendment Act 2015 within my cognizance.

Lastly, on the aforesaid date, time and place, you the accused No.1 to 6 committed the offences punishable U/sec.143, 147, 148, 323, 324, 504 and 506 R/w Sec.149 of IPC against CW.1 and CW.4 that you knowing full well that, CW.1 and CW.4 are belongs to Scheduled Tribe and thereby you accused persons committed an offence punishable U/sec.3(2)(va) of SC/ST (POA) Amendment Act 2015 within my cognizance.

I hereby direct that you be tried by me on the above said charges.
