CHARGE

I Sri. Chennappa Gouda, B.A., LL.B.(Hons), III Addl. District and
Sessions Judge, Belagavi do hereby charge you:

1. Malakari Siddappa Kotre,
Age: 31 years, Occ: Agriculture,
2. Siddappa Sidram Kotre,
Age: 65 years, Occ: Agriculture,
3. Vitthal Siddappa Kotre,
Age: 26 years, Occ: Agriculture,
4. Balakrishna Yallappa Waddar,
Age: 25 years, Occ: Agriculture,
6. Sopanakak Yallappa Waddar,
Age: 21 years, Occ: Agriculture,

All are R/o: Hubbarawadi, Tq: Raibag,
Dist: Belagavi.

as follows:

That you on 14.02.2019 at about 08.30 a.m, at
Hubbarawadi village, within the jurisdiction of Raibag P.S., you the
accused person No.1 to 6, were being the members of an

unlawful assembly with an intention to commit some criminal acts and thereby committed an offence punishable U/sec.143 of IPC, within my cognizance.

Secondly, on the aforesaid date, place and time, you the accused No.1 to 5 were a members of unlawful assembly, in prosecution of common object of that assembly, have committed the offence of rioting and thereby you have committed the offence punishable U/sec.147 of IPC within my cognizance.

Thirdly, on the aforesaid date, time and place, you the accused No.1 to 5 were a members of an unlawful assembly, in prosecution of common object of that assembly, have committed the offence of rioting with deadly weapons like sickle, air pump and stone and thereby you have committed the offence punishable U/sec.148 of IPC within my cognizance.

Fourthly, on the aforesaid date, time and place, you the accused No.1 to 5 were a members of unlawful assembly, in prosecution of common object of that assembly, have assaulted CW.1 Smt.Mallavva Mutteppa Bhajantri and CW.8 Mutteppa Laxman Bhajantri with hands, causing hurt and bodily pain to them and thereby you have committed the offence punishable U./ sec. 323 R/w Sec.149 of IPC within my cognizance.

Fifthly, on the aforesaid date, time and place, you the accused No.1 to 5 were a members of unlawful assembly, in prosecution of common object of that assembly, have assaulted

CW.8 with sickle and air pump on his body, causing simple injuries to him and thereby you have committed the offence punishable U/sec. 324 R/w Sec.149 of IPC within my cognizance.

Sixthly, on the aforesaid date, time and place, you the accused No.1 to 5 were a members of unlawful assembly, in prosecution of common object of that assembly, you accused persons voluntarily causing hurt CW.8 with sickle and air pump on various parts of his body and he sustained grievous injury and thereby you have committed an offence punishable U/sec.326 R/w Sec.149 of IPC within my cognizance.

Seventhly, on the aforesaid date, time and place, you accused No.1 to 5, were member of an unlawful assembly, in prosecution of the common object of that assembly, you A.No.5 used criminal force against the CW.1 with the intention of disrobing you accused No.5 pulled and grabbed the saree of CW.1 and so also assaulted CW.1, thus in order to outrage modesty of CW.1 and thereby you have committed an offence punishable U/sec.354(B) R/w Sec.149 of IPC within my cognizance.

Eighthly, on the above said date, time and place, you accused No.1 to 5 were a members of unlawful assembly, in prosecution of common object of that assembly, you have intentionally insulted CW-1 and 8 abusing them in filthy language and thereby gave provocation to CW-1 and 8 knowing it to be likely that such provocation would cause them to break the public

peace and thereby you have committed an offence punishable U/ sec. 504 R/w Sec. 149 of IPC, within my cognizance.

Ninethly, on the aforesaid date, place and time, you the accused No.1 to 5 were a members of unlawful assembly, in prosecution of common object of that assembly, you have committed criminal intimidation by posing life threat to CW.1 and 8 and thereby you have committed the offence punishable U/sec.506 R/w Sec.149 of IPC within my cognizance.

Tenthly, on the aforesaid date, place and time, you the accused No. 1 to 3 knowing full well that CW.1 and 8 belongs to Schedule Caste community intentionally insulted them with an intent to humiliate them in a place within a public view and thereby you have committed an offence punishable under section 3(1)(r) of SC/ST (POA) Act 1989 and Amendment Act 2015 within my cognizance.

Eleventhly, on the aforesaid date, place and time, these accused No.1 to 3 knowing full well that CW.1 and 8 belongs to Schedule Caste you accused persons abused CW1 and 8 by taking the name of their caste in a place within a public view and thereby you have committed an offence punishable under section 3(1)(s) of SC/ST (POA) Act 1989 and Amendment Act 2015 within my cognizance.

Twelvethly, on the aforesaid date, time and place, you the accused No.1 to 3 intentionally touched CW.1 who belongs to

Scheduled Caste and such type of touching was sexual in nature and was without the recipient's consent and you thereby committed an offence punishable U/sec.3(1)(w) of SC/ST (POA) Act 1989 and Amendment Act 2015 within my cognizance.

Lastly, on the aforesaid date, place and time, you the accused No.1 to 3 committed the offences punishable under section 143, 147, 148, 323, 324, 326, 354(B), 504, 506 of IPC against CW.1 and CW.8 you knowing full well that, CW1 and 8 belongs to Schedule Caste and thereby you have committed an offence punishable under section 3(2)(va) of SC/ST (POA) Act 1989 and Amendment Act 2015 within my cognizance.

I hereby direct that you be tried by me on the above said charges.
