CHARGE

I Sri. Chennappa Gouda, B.A., LL.B.(Hons), III Addl. District and
Sessions Judge, Belagavi do hereby charge you:

1. Sanju Nagappa Dabali,
Age: 25 years,
R/o: Basava Nagar, Kodachavad,
Tq: Khanapur, Dist: Belagavi.

as follows:

That on 11.12.2023 you the accused make a call to the complainant Ashwata Madar to her mobile and said that, they both will get married, you threatened by saying that if she does not come you would cause danger to your life. She believed your words, the complainant without informing her parents she at 7.00 p.m., left her house from Peeranwadi within the jurisdiction of Belagavi Rural PS.

You the accused had taken the complainant to Parle village. There both of you stayed for two days and you the accused made the complainant to believe that, they would come to the complainant's house and speak about the marriage before her parents and arrange to get married to her and left her at Belagavi Bus Stand at about 3.00 p.m., on 13.12.2023. The complainant left the CBT bus stand and went to her house and informed about the same to her parents. Her parents called you on phone for which you did not pick up. They called Parashu Ravaji and enquired him. He told that, your parents were threatening and saying that the complainant belongs to Schedule cast and if you marry her they would take poison and die. Though, you the accused very well aware that the complainant belongs to Schedule caste, you playing a dram of love with the complainant for a period of 3 years and when the complainant requested to marry her, your family members have refused for her marriage with you due to the reason that, she belongs to Schedule caste and you the accused has deceived the complainant and thereby you have committed an offence punishable U/sec.417 of IPC within my cognizance.

Secondly, on the aforesaid date, time and place, you the accused with an intention, you have committed criminal intimidation by posing life threat to the CW.1 and thereby you have

committed an offence punishable U/sec.506 of IPC within my cognizance.

Secondly, on the aforesaid date, time and place, you the accused knowing full well that the CW.1 belongs to Schedule Caste community intentionally insulted her with an intent to humiliate the member of schedule Caste in a place within public view and thereby you have committed an offence punishable U/sec.3(1)(r) of SC/ST (POA) Act 1989 and Amendment Act 2015 within my cognizance.

Lastly, on the aforesaid date, time and place, you the accused knowing full well that the CW.1 belongs to schedule Caste abused her by taking the name of her caste in a place within a public view and thereby you committed an offence punishable U/sec.3(1)(s) of SC/ST (POA) Act 1989 and Amendment Act 2015 within my cognizance.

I hereby direct that you be tried by me on the above said charges.
