CHARGE

I Sri. Chennappa Gouda, B.A., LL.B.(Hons), III Addl. District and
Sessions Judge, Belagavi do hereby charge you:

1. Sandeep Raju Kolkar,
Age: 32 years, Occ: Auto Driver,
R/o: H.No.62, Ambedkar Galli,
Majagaon, Belagavi.
2. Kumar Santosh Rajangali,
Age: 19 years, Occ: Painting work,
R/o: H.No.342, Ambedkar Galli,
Majagaon, Belagavi.
3. Ravi Gangappa Guledakoppa,
Age: 25 years, Occ: Tiles Painting work,
R/o: 2nd Cross, Kalmeshwar Nagar,
Majagaon, Belagavi.
4. Pradeep Ningappa Kolkar,
Age: 24 years, Occ: Painting work,
R/o: H.No.370, Ambedkar Galli,
Majagaon, Belagavi.

5. Shivakumar Chandrakant Mane,
Age: 22 years, Occ: Driver,
R/o: H.No. CCB 49, 2nd Cross,

as follows:

That you accused No.1 to 5 for the last 3 months prior to 29.06.2022 and on the same day, at about 11.00 p.m at Majagaon village, within the jurisdiction of Udyambag PS., were being the members of an unlawful assembly, in prosecution of the common object of that assembly, accused No.1 to 5 hatched a plan to do away with the life of the deceased Yalleshappa Shivaji Kolkar accordingly the deceased was killed on 29.06.2022 and you thereby have committed an offence punishable U/sec.120(b) R/w Sec.149 of IPC within my cognizance.

Secondly, on 29.06.2022 at about 11.00 p.m at Majagaon village, within the jurisdiction of Udyambag PS., you the accused No.1 to 5 were being the members of an unlawful assembly, in prosecution of the common object of that assembly, which you accused persons abused and assaulted the deceased Yalleshappa

Shivaji Kolkar and thereby you have committed an offence punishable U/sec.143 of IPC within my cognizance.

Secondly, on the aforesaid date, time and place, you the accused No.1 to 5 were being the members of unlawful assembly, in prosecution of the common object of that assembly, which you accused persons abused and assaulted the deceased Yalleshappa Shivaji Kolkar and to commit the offence thereby you have committed rioting an offence punishable U/sec.147 IPC within my cognizance.

Thirdly, on the aforesaid date, time and place, you the accused No.1 to 5 were being the members of an unlawful assembly, in prosecution of the common object of that assembly, which you accused No.1 to 4 committed rioting with deadly weapon namely sickle (ಕೊಯ್ತಾ), knife, axe and sword (ತಲ್ವಾರ) and thereby you have committed an offence punishable U/sec.148 IPC within my cognizance.

Fourthly, on the above said date, time and place, you the accused No.1 to 5 were being the members of an unlawful assembly, in prosecution of the common object of that assembly, you accused No.1 has provoked accused No.2 to 5 to gave life threat to deceased

Yalleshappa Shivaji Kolkar and thereby you have committed an offence punishable U/sec.109 R/w Sec.149 of IPC within my cognizance.

Fourthly, on the aforesaid date, time and place, you the accused No.1 to 5 were being the members of an unlawful assembly, in prosecution of the common object of that assembly, you accused No.1 to 4 committed murder of deceased Yalleshappa Shivaji Kolkar and assaulted with sickle (ಕೊಯ್ತಾ), knife, axe and sword (ತಲ್ವಾರ) on various parts of deceased body and killed him and you thereby you accused No.1 to 4 have committed an offence punishable U/sec.302 R/w Sec.149 of IPC within my cognizance.

Lastly, on the aforesaid date, time and place, you the accused No.3 and 5 knowing full well that, deceased Yalleshappa Shivaji Kolkar belongs to Scheduled Caste community, you have committed an offence punishable U/sec.143, 147, 148, 120(B), 109 and 302 of IPC against him which is punishable with life imprisonment and thereby you have committed an offence punishable U/sec.3(2)(v) of SC/ST (POA) Amendment Act 2015 within my cognizance.

I hereby direct that you be tried by me on the above said charges.
