as follows:

That on 14.09.2022 at about 06.00 p.m., and 07.00 p.m., in the limits of Suttatti village, within the Jurisdiction of Aigali PS., you accused No.1 to 8 were being the members of an unlawful assembly, in prosecution of the common object of that assembly, which you accused persons abused and assaulted the CW.1 Shankar Gadiwaddar, CW.8 Suresh Gadiwaddar, CW.9 Sabu Gadiwaddar, CW.10 Ashok Gadiwaddar, CW.11 Ajeet Gadiwaddar and CW.12 Raju Gadiwaddar and committing some criminal acts against them and thereby you have committed an offence punishable U/sec.143 of IPC within my cognizance.

Secondly, on the aforesaid date, time and place, you the accused No.1 to 8 were being the members of unlawful assembly, in prosecution of the common object of that assembly, which you accused persons abused and assaulted the CW.1, CW.8 to CW.12

and to commit the offence thereby you have committed rioting an offence punishable U/sec.147 of IPC within my cognizance.

Thirdly, on the aforesaid date, time and place, you the accused No.1 to 8 were being the members of an unlawful assembly, in prosecution of the common object of that assembly, which you accused persons committed rioting with deadly weapon namely cable wire and Ragol (ಕಬ್ಬಿಣದ ರಾಗೋಲದಿಂದ) and thereby you have committed an offence punishable U/sec.148 of IPC within my cognizance.

Fourthly, on the aforesaid date, at about 06.00 p.m, in the limits of Suttatti village, you accused No.1 to 8 were being the members of unlawful assembly, in prosecution of common object of that assembly, you the accused No.1 and 2 have compulsively kidnapped the CW.8 Suresh Gadiwaddar's without the consent and thereby committed an offence punishable U/sec.363 R/w Sec.149 IPC within my cognizance.

Fifthly, on the aforesaid date, at about 06.00 pm and 07.00 pm., in the limits of Suttatti village, you the accused No.1 to 8 were being the members of an unlawful assembly, in prosecution of the common object of that assembly, which you accused persons voluntarily caused hurt to CW.1, CW.8, CW.9, and CW.12 and assaulted them with cable wire, ragol (ಕಬ್ಬಿಣದ ರಾಗೋಲದಿಂದ) and sticks on their bodies, causing simple injuries to

them and thereby you have committed an offence punishable U/sec.324 R/w Sec.149 of IPC within my cognizance.

Sixthly, on the above said date, time and place, you accused No.1 to 8 were being the members of unlawful assembly, in prosecution of common object of that assembly, you have intentionally insulted CW.1, CW.8 to CW.12 abusing them in filthy language and thereby gave provocation to CW.1, CW.8 to CW.12 knowing it to be likely that such provocation would cause them to break the public peace and thereby you have committed an offence punishable U/sec.504 R/w Sec.149 of IPC within my cognizance.

Seventhly, on the aforesaid date, time and place, you the accused No.1 to 8 were being the members of an unlawful assembly, in prosecution of the common object of that assembly, you have committed criminal intimidation by posing life threat to CW.1, CW.8 to CW.12 and thereby you have committed the offence punishable U/Sec.506 R/w Sec.149 of IPC and within my cognizance.

Eighthly, on the aforesaid date, time and place, you the accused No.1 to 8 knowing full well that CW.1, CW.8 to CW.12 belongs to Scheduled Caste community intentionally you accused persons insulted them with an intent to humiliate them in a place within public view and you thereby committed an offence

punishable U/sec.3(1)(r) of SC/ST (POA) Act 1989 and Amendment Act 2015 within my cognizance.

Ninthly, on the aforesaid date, time and place, you accused No.1 to 8 knowing full well that the CW.1, CW.8 to CW.12 belongs to schedule caste you accused persons abused them by taking the name of their caste in a place within a public view and thereby you committed an offence punishable U/sec.3(1)(s) of SC/ST (POA) Act 1989 and Amendment Act 2015 within my cognizance.

Lastly, on the aforesaid date, time and place, you the accused No.1 to 8 have committed the offences punishable U/sec.143, 147, 148, 363, 324, 504 and 506 R/w Sec.149 of IPC against CW.1, CW.8 to CW.12, that you knowing full well that, they belongs to Scheduled Caste and thereby you have committed an offence punishable U/sec.3(2)(va) of SC/ST (POA) Act 1989 and Amendment Act 2015 within my cognizance.

I hereby direct that you be tried by me on the above said charges.
