as follows:

CHARGE

That on 15.01.2024, at about 05.30 p.m., when the complainant/CW1 was proceeding on his motorbike along with injured Akash Lagmanna Naik/CW6 as pillion rider and Lagamappa Gujanal/CW7 was proceeding on his motorbike from Bhutaramanahatti village, on Laxmi Temple road near small bridge within the limits of Kakati police station towards Highway, you accused stopped their motorbikes with regard to making sound of motorbikes and wrongfully restrained them from moving further with an intention to commit murder of CW6 and thereby you have

committed an offence punishable under Section 341 of IPC and within the cognizance of this court.

Secondly, on the above said date, time and place, you accused with an intention to commit the murder of CW6, picked up the quarrel with CW1, 6 and 7 and abused them with filthy language, with an intention to insult them and to provoke them to break the public peace or to commit any offence and thereby you have committed an offence punishable under Section 504 of IPC and within the cognizance of this court.

Lastly, on the above said date, time and place, you accused with an intention to commit the murder of CW6, assaulted him with club on his head, causing grievous injury, knowing that causing such act on the vital part of body of any person is likely to cause his death and thereby, attempted to commit murder of CW6 and thereby, you have committed an offence punishable under Section 307 of IPC and within the cognizance of this court.

And I hereby direct that you be tried by this court on the above said charges.
