The date is fixed for production and E/R of W/A. The Ld. App is present. The NER of the accused persons are received. The accused Md. Tarek @ Tarique is produced from PCH, Kolkata. The Ld. Advocate for the accused persons against whom W/A was issued filed bail petition along with fresh vokalatnama. The Ld. App raised strong objection against the bail petition. The Ld. Advocate for the accused persons namely Rokeya Begum and Israt Begum has submitted that the accused persons do not reside in the address given in the charge sheet and they had no such relation with the accused person No-1 due to his mental disturbances. The Ld. Advocate has submitted that the Accused no- 2 is the mother of accused no-1 but as he does not take her care and disturbed her so she resides in the matrimonial house of Accused no-3, her daughter who is suffering from ailments due to recent tumor operation. The Ld. Advocate has submitted that the accused persons did not turn up as it was not within their knowledge and they have no intention to avoid the direction of the Court. The Ld. Advocate has also submitted that the accused person no-3 has two kids who are dependent on her and both the accused persons are on fasting due to Ramdan.

Heard. Perused. Considered.

There is no bail petition for accused no-1. The record goes to show that the accused no-2 and Accused no-3 are made accused for committing the offence u/s 342/34 of I.P.C and the accused no-1 is made an accused for committing the offences u/s 342/323/354/417/376/34 of I.P.C. The offence under which the charge sheet against accused no-2 & 3 is filed is bailable in nature. Apart from that, the accused persons have surrendered before the Court as soon as they have received information in their present address. The accused persons have submitted before the Court that they would face trial of the case and appear before the Ld. Judge as per direction. Considering the same, I am inclined to allow the petition of bail of both the accused persons namely Rokeya Begum and Israt Begum today. The accused may find bail of Rs. 500/- each with one registered surety of like amount id to J/C till 28.04.2023.

If on bail, to date for appearance before the Ld. Chief Judge, City Sessions Court, Calcutta. The accused No-1 is remanded to J/C till 28.04.2023.

To 28.04.2023 for production of Accused No-1 before the Ld. Ld. Chief Judge, City Sessions Court, Calcutta.

Later,

The bail bonds of Rs. 500/- each for the accused persons namely Rokeya Begum and Israt Begum are filed by Surety which are found fit and proper. Let the accused persons be released at once of not detained in any other case. Re-call W/A against the accused namely accused persons namely Rokeya Begum and Israt Begum at once.

The case is exclusively triable by Ld. Court of Sessions and in view of that the record is transmitted to the Ld. Court.

Let the entire case record along with all documents in it be sent to the Ld. Chief Judge, City Sessions Court, Calcutta. BC-I and BC-II are directed to take steps immediately.
