:: COMMITTAL ORDER UNDER SECTION 232 OF B.N.S.S ::

This is a charge-sheet filed by the CPI of Athani Circle, Athani against the accused person for the offences punishable U/Sec. 326(g), 103(1), 109(1) 352 and 351(2) BNS, 2023, in Aigali PS, Cr.No.183/2025.

2. On perusal of the records, it is alleged that the accused has committed the offences punishable U/Sec. 326(g), 103(1), 109(1) 35 and 351(2) BNS, 2023, which are exclusively triable by the Hon'ble Court of Sessions. The accused is in judicial custody.

3. Acting U/Sec.230 of BNSS-2023 copies of the prosecution papers already supplied to the accused person. On hearing this court convinced that this case is to be committed to the Hon'ble XI Addl. District and Sessions Court, Belagavi Sitting at Athani, for trial. Accordingly, this court proceed to pass the following:

The accused is remanded to custody during and until the conclusion of the trial before the Hon'ble XI Addl. District and Sessions Court, Belagavi Sitting at Athani subject to provisions of bail.

The jail authority is hereby directed to produce the Accused before the Hon'ble XI Addl. District and Sessions Court, Belagavi Sitting at Athani as and when summoned subject to provisions of bail.

Office to furnish order of committal to the office of learned Public Prosecutor, Belagavi.

Office is directed to submit entire records of this case and properties to the Hon'ble XI Addl. District and Sessions Court, Belagavi Sitting at Athani, as per its direction.

Issue intimation / warrant accordingly.
