**ORDER ON PETITION FILED UNDER SECTION 13 (3) OF
REGISTRATION OF BIRTHS AND DEATHS ACT, 1969 R/W.10
(3) OF KARNATAKA BIRTHS AND DEATHS ACT, 1970**

The minor petitioner was born on 31.07.2003 at Neginhal village, Tq: Bailhongal. The petitioner has approached to the respondent with request to issue his birth certificate as he is in need of the same for higher education and employment. The respondent in-turn got issued endorsement stating that birth particulars of petitioner, is not entered in the register in the office of Respondent. Hence, this petition.

3. Respondent has appeared on record. There is no contest to the petition.

4. In support of the case petitioner is examined as PW.1 and got marked Ex.P.1 to 4 documents and closed the side.

5. Heard learned Counsel for the petitioner at length and perused the materials placed on record.

6. Upon hearing argument and on perusal of material placed on records, following points arise for consideration:

1. Whether the petitioner has made out sufficient grounds for allowing the petition?

2. What order?

7. My answer to the above points are as under:

8. POINT NO.1:- In order to prove the case, petitioner is examined as P.W.1 and reiterated the petition contents in examination-in-chief affidavit. Petitioner has produced Ex.P.1 is the non availability certificate, Ex.P.2 is the school Certificate, Ex.P.3 is the notarized copy of Adhaar Card of PW-1 and Ex.P.4 is the notarized copy of SSLC Marks Card of PW-1. Wherein in the Ex.P-2 the date of birth of petitioner is mentioned as 31.07.2003 and also in Ex.P.4 the date of birth of petitioner is mentioned as 31.07.2003. The said documents indicate that petitioner is resident of Neginhal village, Tq: Bailhongal and Dist: Belagavi and he has got local base. As respondent has not contested main petition, testimony of P.W.1 and documentary evidence produced on behalf of petitioner remained unchallenged and uncontroverted. Therefore, there is no reason to disbelieve the evidence given by petitioner.

9. It is also trite that in a proceeding under section 13 (3) of Registration of Births and Deaths Act, court is concerned with the factum of birth or death and date of birth or death is not relevant. This proposition finds support from the ratio laid down by Hon'ble High Court of Karnataka in **2000 (4) KCCR 2674 (State of Karnataka V/s Smt. Annakka)**, wherein it was held that the **The Magistrate in a proceeding Under Section 13(3) only ascertains the birth of the child and date is not the material consideration, as such directions bind only the Registration Office Under the Act to make an entry and does not carry higher probative value.**

10. Hence, in the light of principles emerged from the decision referred above, petition is required to be allowed. Hence, I answer the point No.1 in the Affirmative.

11. **POINT NO.2:-** For the foregoing reasons, I proceed to pass the following:

:ORDER:

Petition filed under Section 13(3) of Birth and Death Registration Act, 1969 R/w. Rule 10(3) of Karnataka Births and Deaths Act, 1970 is hereby allowed.

Respondent is directed to enter the date of birth of Petitioner viz., Kumar. Subhashchandra S/o Gopal Patil as 31.07.2003 and place of birth as Neginhal village, Tq: Bailhongal in the concerned registers and issue birth Certificate to the petitioner after collecting necessary fee and fine.

No order as to cost.
