That, firstly on 02.10.2024 at about 08.20 p.m. at from 3rd cross near Jalakumb to 1st cross of Bhim-Nagar at Nippani within the limits of Nippani Town P. S. ; you : the accused no.1 to 11 formed an unlawful assembly, the common object of which was to commit the murder of one Ashrafali Nagarji and thereby, committed the offence punishable U/Sec. 189 (2) of B.N.S. 2023 and within the cognizance of this Court of Session.

Secondly, on the above mentioned date, time and place : you : the accused no.1 to 11 being the members of an

unlawful assembly and in prosecution of common object of such assembly used force or violence in assaulting the victim Asharfali Sherali Nagarji and thereby, committed the offence of rioting punishable U/Sec. 191 (2) of B.N.S. 2023 and within the cognizance of the Court of Session.

Thirdly, on the above mentioned date, time and place ; you ; the accused no.1 to 11 being the members of an unlawful assembly and in prosecution of common object armed with deadly weapons *Talawar & Machet* and thereby, committed the offence punishable U/Sec. 191 (3) of B.N.S. 2023 and within the cognizance of this Court of Session.
