R/o. Mugalkhod,
Near Kanteppanavar Tota School,
Tal : Raibag, Dist: Belagavi.

A3. Beerappa Pundaleek Shegunashi,
Age: 38 years, Occ: Agriculture,
R/o. Mugalkhod,

as follows :

That on 17.04.2020 at about 1200 hours in RS No. 701/4 in front of the house of complainant in Mugalkhod Village of Raibag taluk, in furtherance of common intention, you all the accused have voluntarily caused hurt to the complainant and CW-5 thereby, committed the offence punishable U/Sec.323 R/w. Sec. 34 of the I.P.C. and within my cognizance.

Secondly, on the aforesaid date and at the aforesaid time and place, in furtherance of common intention, you all the accused have assaulted the complainant and CW-5 with hands and stones voluntarily causing hurt and thereby committed the offence punishable U/Sec. 324 r/w Sec. 34 of the I.P.C. and within my cognizance.

Thirdly, on the aforesaid date and at the aforesaid time and place, in furtherance of common intention, you the accused No.4 assaulted CW-5 with intent to outrage her modesty thereby committed the offence punishable U/Sec. 354 r/w Sec. 34 of the I.P.C. and within my cognizance.

Fourthly, on the aforesaid date and at the aforesaid time and place, in furtherance of common intention, you all the accused used criminal force and made the complainant to drink the poison with the intention to kill him thereby committed the offence punishable U/Sec. 307 r/w Sec. 34 of the I.P.C. and within my cognizance.

Fifthly, on the aforesaid date and at the aforesaid time and place, in furtherance of common intention, you all the accused have picked up quarrel with the complainant and CW.5 abused them in filthy language thereby, committed the offence punishable U/Sec.504 r/w. Sec. 34 of the I.P.C. and within my cognizance.

Lastly, on the aforesaid date and at the aforesaid time and place, in furtherance of common intention, you all the accused have picked up quarrel with the complainant and CW.5 and threatened to cause their death and thereby, committed the offence punishable

U/Sec.506 r/w. Sec. 34 of the I.P.C. and within my cognizance.

And I hereby direct that you be tried by this Court on the above said charges.
