I, Smt.Kaveri, B.A., LL.M, VII Additional District and Sessions Judge, Belagavi, sitting at Chikkodi do hereby charge you :

Tal : Chikodi, Dist: Belagavi.
- A2. Jaya @ Jayashri Raju Munde,
Age: 40 years, Occ: Household Work,
R/o. Karoshi, Tal : Chikodi,
Dist: Belagavi.
- A3. Sangeeta Sanjay Munde,
Age: 35 years, Occ: Household Work,
R/o. Karoshi, Tal : Chikodi,
Dist: Belagavi.

A4. Sachin Raju Munde,
Age: 23 years, Occ: Private Work,
R/o. Karoshi, Tal : Chikodi,
Dist: Belagavi.

A5. Vinayak Sanju Munde,
Age: 21 years, Occ: Business,
R/o. Karoshi, Tal : Chikodi,
Dist: Belagavi.

as follows :

That on 23.01.2021 at about 20.00 hours in the land bearing RS No. 242/9 of Karoshi Village, in prosecution of common object, you all the accused picked up quarrel with CW.4 and CW.5 by forming unlawful assembly thereby committed the offence punishable U/Sec. 143 r/w Sec. 149 of the I.P.C. and within my cognizance.

Secondly, on the aforesaid date and at the aforesaid time and place, in prosecution of common object, you all the accused have committed riot and thereby, committed the offence punishable U/Sec.147 r/w. Sec.149 of the I.P.C. and within my cognizance.

Thirdly, on the aforesaid date and at the aforesaid time and place, in prosecution of common object, you all the accused have committed riot with sticks, stones and

bricks and thereby, committed the offence punishable U/Sec.148 r/w. Sec. 149 of the I.P.C. and within my cognizance.

Fourthly, on the aforesaid date and at the aforesaid time and place, in prosecution of common object, you all the accused have voluntarily caused hurt to the CW.4 and CW.5 thereby, committed the offence punishable U/Sec.323 R/w. Sec. 149 of the I.P.C. and within my cognizance.

Fifthly, on the aforesaid date and at the aforesaid time and place, in prosecution of common object, you all the accused have assaulted CW.4 and CW5 with sticks, stones and bricks and voluntarily caused hurt and thereby committed the offence punishable U/Sec. 324 r/w Sec. 149 of the I.P.C. and within my cognizance.

Sixthly, on the aforesaid date and at the aforesaid time and place, in prosecution of common object, you all the accused have voluntarily caused grievous hurt by assaulting the CW.4 and CW5 with sticks, stones and bricks and thereby committed the offence punishable U/Sec. 326 r/w Sec. 149 of the I.P.C. and within my cognizance.

Seventhly, on the aforesaid date and at the aforesaid time and place, in prosecution of common object, you all the accused have voluntarily caused grievous hurt to CW.4 and CW.5 by assaulting them with sticks, stones and bricks with the intention to kill them thereby committed the offence punishable U/Sec. 307 r/w Sec. 149 of the I.P.C. and within my cognizance.

Lastly, on the aforesaid date and at the aforesaid time and place, in prosecution of common object, you all the accused have picked up quarrel with the CW.4 and CW.5 abused them in filthy language thereby, committed the offence punishable U/Sec.504 r/w. Sec. 149 of the I.P.C. and within my cognizance.

And I hereby direct that you be tried by this Court on the above said charges.
