AS FOLLOWS :

That, firstly on 28.03.2019 at about 10.00 a. m. at Kallakatti area towards primary school cross at Basapur village within the limits of Yamakanamaradi P. S. : you ; the accused no. 1 to 8 were the members of an unlawful assembly, the common object of which was to commit the offence against the complainant and C. Ws. 4 to 6 namely Mallavva, Rayappa, Suresh and Kempanna and thereby, committed the offence punishable U/Sec. 143 of I. P. C. within the cognizance of this Court of Session.

Secondly, on the above mentioned date, time and place : you : the accused no. 1 to 8 being the members of an unlawful assembly and in prosecution of common object of such assembly used force or violence in assaulting the complainant and C.Ws.4 to 6 and thereby, committed the offence of rioting punishable U/Sec. 147 of I. P. C. within the cognizance of the Court of Session.

Thirdly, on the above mentioned date, time and place ; you ; the accused no. 1 to 8 being the members of an unlawful assembly and in prosecution of common object armed with deadly weapons – stone, iron rod and club which were used as weapons of offence and thereby, committed the offence punishable U/Sec. 148 of I. P. C. within the cognizance of this Court of Session.

Fourthly, on the above mentioned date, time and place ; you ; the accused no. 1 to 8 being the members of an unlawful assembly and in prosecution of common object

wrongfully restrained the C. Ws. 4 to 6 and thereby, committed the offence punishable U/Sec. 341 r/w Sec. 149 of I. P. C. within the cognizance of this Court of Session.

Fifthly, on the above mentioned date, time and place ; you ; the accused no. 1 to 8 being the members of an unlawful assembly and in prosecution of common object voluntarily caused hurt to complainant and C.Ws. 4 to 6 by means of stone, iron road & club used as weapon of offence and thereby, committed the offenses punishable U/Sec. 324 r/w Sec. 149 of I. P. C. within the cognizance of this Court of Session.

Sixthly, on the above mentioned date, time and place ; you ; the accused no. 1 to 8 being the members of an unlawful assembly and in prosecution of common object attempted to murder the complainant and C. Ws. 4 to 6 and thereby, committed the offenses punishable U/Sec. 307 r/w Sec. 149 of I. P. C. within the cognizance of this Court of Session.

Seventhly, on the above mentioned date, time and place ; you; the accused no. 1 to 8 being the members of an unlawful assembly and in prosecution of common object intentionally insulted the complainant and C. Ws. 4 to 6 by scolding them intending or knowing it to be likely that such provocation will cause them to break public peace or to commit any other offence and thereby, committed the offenses punishable U/Sec. 504 r/w Sec. 149 of I. P. C. within the cognizance of this Court of Session.

Lastly, on the mentioned date, time and place ; you ; the accused no. 1 to 8 being the members of an unlawful assembly and in prosecution of common object

committed the acts of criminal intimidation against the complainant, C.Ws. 4 to 6 and their property with intent to cause alarm and thereby, committed the offenses punishable U/Sec. 506 r/w Sec. 149 of I. P. C. within the cognizance of this Court of Session.

And I hereby direct that you - the accused no. 1 to 8 shall be tried by this Court on the above said charges.
