That on 25.08.2021 at about 01.30 p.m. in Pratibha Nagar of Nippani taluk, you all the accused have formed unlawful assembly thereby, committed the offence punishable U/Sec.143 r/w. Sec.149 of the I.P.C., and within my cognizance.

Secondly, on the aforesaid date and at the aforesaid time and place, in prosecution of common object, you all the accused have committed riot and thereby, committed the offence punishable U/Sec.147 r/w. Sec.149 of the I.P.C. and within my cognizance.

Thirdly, on the aforesaid date and at the aforesaid time and place, in prosecution of common object, you all the accused have committed riot with Sticks and Belt and thereby, committed the offence punishable U/Sec.148 r/w. Sec. 149 of the I.P.C. and within my cognizance.

Fourthly, on the aforesaid date and at the aforesaid time and place, in prosecution of common object, you all the accused have assaulted complainant and CW8 with Sticks and Belt voluntarily causing hurt and thereby committed the offence punishable U/Sec. 324 r/w Sec. 149 of the I.P.C. and within my cognizance.

Fifthly, on the aforesaid date and at the aforesaid time and place, in prosecution of common object, you all the accused have voluntarily caused grievous hurt to complainant and CW8 by assaulting them with Sticks and Belt with the intention to kill them thereby committed the offence punishable U/Sec. 307 r/w Sec. 149 of the I.P.C. and within my cognizance.

Sixthly, on the aforesaid date and at the aforesaid time and place, in prosecution of common object, you all the accused have picked up quarrel with the complainant and CW.8 and abused them in filthy language thereby, committed the offence punishable U/Sec.504 r/w. Sec. 149 of the I.P.C. and within my cognizance.

Lastly, on the aforesaid date and at the aforesaid time and place, in prosecution of common object, you all the accused have picked up quarrel with the complainant

and CW.8 and threatened to cause their death and thereby, committed the offence punishable U/Sec.506 r/w. Sec. 149 of the I.P.C. and within my cognizance.

And I hereby direct that you be tried by this Court on the above said charges.
