as follows :

That on 20.04.2014 at 5:00 p.m. in front of the house of the complainant, in prosecution of common object, you formed unlawful assembly with an intention to commit the offence and thereby, committed the offence punishable U/Sec. 143 r/w section 149 of the I.P.C. and within my cognizance.

Secondly, on the aforesaid date, time & place, in prosecution of common object, you committed riot and thereby, committed the offence punishable U/Sec. 147 r/w section 149 of the I.P.C., and within my cognizance.

Thirdly, on the aforesaid date, time & place, in prosecution of common object, you committed riot by holding deadly weapons and thereby, committed the

offence punishable U/Sec. 148 r/w section 149 of the I.P.C., and within my cognizance.

Fourthly, on the aforesaid date and at the aforesaid time and place, in prosecution of common object, you and deceased accused insulted the complainant and CW4 to CW11 by abusing in filthy words as “ಭೋಸಡಿ ಮಕ್ಕಳಿಯಾ” with intention to provoke to commit breach of peace and thereby, committed the offence punishable U/Sec. 504 r/w section 149 of the I.P.C. and within my cognizance.

Fifthly, on the aforesaid date and at the aforesaid time and place, in prosecution of common object, you and accused-Laxman and accused-Halappa assaulted by clubs on the head and all over the body of the complainant and deceased accused-Lagama and you accused-Yallappa assaulted by club to the CW.5-Kenchappa, you accused-Muttappa and you accused-Ningappa assaulted by club to the CW.4-Mayappa, you accused-Mayappa and deceased accused – Suresh assaulted by the club to the CW.7-Manjunath and you accused-Lagama and Kamalawwa assaulted by club to CW.10-Shyanakka, you accused-Laxman and Hallappa assaulted by club to CW.11-Lagamanna and caused grievous injuries and thereby, committed the offence

punishable U/Sec. 324 r/w section 149 of the I.P.C. and within my cognizance.

Sixthly, on the aforesaid date and at the aforesaid time and place, in prosecution of common object, you accused-Gangawwa and Laxmawwa assaulted by the club to the CW.8-Mahadevi and you accused-Krishnawwa and Gangawwa assaulted by the club to the CW.9-Annawwa and you accused-Beerappa and Lakkappa assaulted by the club to the CW.6-Ningappa and caused grievous hurt and thereby committed the offence punishable U/Sec. 326 r/w section 149 of the I.P.C. and within my cognizance.

Seventhly, on the aforesaid date and at the aforesaid time and place, in prosecution of common object, you and deceased accused assaulted to the complainant and C.W.6 to C.W.11 by hands and caused simple hurt and thereby, committed the offence punishable U/Sec. 323 r/w section 149 of the I.P.C. and within my cognizance.

Eighthly, on the aforesaid date and at the aforesaid time and place, in prosecution of common object, you and deceased accused assaulted to the complainant and CW.6 to CW.11 by clubs and hands and made attempt to murder them and thereby, committed the offence

punishable U/Sec. 307 r/w section 149 of the I.P.C. and within my cognizance.

Lastly, on the aforesaid date and at the aforesaid time and place, in prosecution of common object, you and deceased accused threatened the complainant and CW.4 to CW.11 to kill them and thereby, committed the offence punishable U/Sec. 506 r/w section 149 of the I.P.C. and within my cognizance.

And I hereby direct that you be tried by this Court on the above said charges.
