at Chikkodi do hereby charge you :

as follows :

That on 31.12.2014 at about 10-30 a.m., behind the house of one Balakrishna, you were members of unlawful assembly in furtherance of common object and thereby, committed the offence punishable U/Sec.143 R/w. Sec.149 of the I.P.C., and within my cognizance.

Secondly, on the aforesaid date and at the aforesaid time and place, in furtherance of common object, you committed riot and thereby, committed the offence punishable U/Sec.147 R/w. Sec.149 of the I.P.C. and within my cognizance.

Thirdly, on the aforesaid date and at the aforesaid time and place, in furtherance of common object, you committed riot with deadly weapons and thereby, committed the offence punishable U/Sec.148 R/w. Sec. 149 of the I.P.C. and within my cognizance.

Fourthly, on the aforesaid date and at the aforesaid time and place, in furtherance of common object, you accused wrongly restrained the witness-Manjunath and thereby, committed the offence punishable U/Sec.341 R/w. Sec.149 of the I.P.C. and within my cognizance.

Fifthly, on the aforesaid date and at the aforesaid time and place, in furtherance of common object, you accused kicked to the complainant and witness-Mallikarjun/Manjunath and caused simple hurt and thereby, committed the offence punishable U/Sec.323 R/w. Sec.149 of the I.P.C. and within my cognizance.

Sixthly, on the aforesaid date and at the aforesaid time and place, in furtherance of common object, you accused assaulted to the complainant and witness-Mallikarjun/Manjunath with sticks and stone and caused grievous hurt and thereby, committed the offence punishable U/Sec.324 R/w. Sec.149 of the I.P.C. and within my cognizance.

Seventhly, on the aforesaid date and at the aforesaid time and place, in furtherance of common object, you insulted the complainant by abusing in filthy words as “ಬೋಸಡಿ ಮಕ್ಕಳಿರಾ” abusing in filthy words with intention to provoke to commit breach of peace and thereby,

committed the offence punishable U/Sec.504 R/w. Sec. 149 of the I.P.C. and within my cognizance.

Lastly, on the aforesaid date and at the aforesaid time and place, in furtherance of common object, you intimidated to the life of complainant and witness- Mallikarjun/Manjunath and thereby, committed the offence punishable U/Sec. 506 R/w. Sec.149 of the I.P.C. and within my cognizance.

And I hereby direct that you be tried by this Court on the above said charges.
