EXAMINATION IN CHIEF BY LEARNED P.P:-

1) Since the year 2013 I am serving as Doctor at Vijaya Ortho and Trauma Centre, Belagavi.

2) In connection with this case, on 28.03.2019 at about 12.29 p.m, when I was in charge of hospital duty, one Rayagonda, a/a 28 years, approached with the history of assault.

3) When examined, the following injuries were noted:

1. Left black eye – right frontal aspect of scalp – swelling present.

C.T. Brain plain – Acute epidural hematoma along left frontal convexity, effacement of adjacent sulci and left lateral ventricle with contralateral midline shift. Fracture of frontal bone on left involving roof of left orbit. Left frontal scalp hematoma.

4) In my opinion, injury No.1 was Grievous in nature. Said injuries might have been caused by use of blunt object and injury was fresh.

5) Accordingly, I issued wound certificate on 10.04.2019 which is now shown to me. Said certificate is marked as Ex.P 1 and signature of witness being identified and marked at Ex.1(A).

6) On the same day at about 12.38 p.m, when I was in charge of hospital duty, one Hanamant, a/a 30 years, approached with the history of assault.

7) When examined, the following injuries were noted:

1. C.L.W present on left parietal scalp - 4 X 1 C.M. muscle deep.
2. Left shoulder, left hip - tenderness present.
Left lower abdomen - 1 X 1 C.M., 2 in number, abrasions present.

8) In my opinion, injury No.1 and 2 were simple in nature. Said injuries might have been caused by use of blunt object and injuries were fresh.

9) Accordingly, I issued wound certificate on 10.04.2019 which is now shown to me. Said certificate is marked as Ex.P 2 and signature of witness being identified and marked at Ex.2(A).

10) Again on 25.07.2019, at the request of I.O, I examined Iron Rods, Stones and Bamboo Sticks now shown to me and gave the further opinion stating that the kind of injuries noted in Ex.P1 and 2 are possible to be caused if the assault is made by use of object like Iron Rods, Stones and Bamboo Sticks, now shown to me. Said objects are now marked at M.O.1 to 6. Witness identified the further opinion and signature on it. Said documents are marked at Ex.P 3 to 5 and signature of witness marked at Ex.P 3(a) to 5(a).

Cross Examination : Counsel for accused prays time. No grounds, hence the prayer is rejected, cross examination taken as nil.

RE-EXAMINATION: Nil.
