4. I state that, It is specifically submits that, the defendants No-3 to 26 and 29 are having no rights in the suit schedule property and the defendant No-27 is having no

authority to issue property extract and receiving revenue on it. Hence the defendants No-3to26 joining hands in gloves with the officials of the defendant No.27 and created bogus property extracts and issued to the defendants No-3to26 which are totally illegal and not binding upon me.

5. Further I state that, already I have filed suit bearing OS No-19/2024 against the defendants No-3 to 26 sought the relief of Mandatory Injunction and same is pending before the hon'ble 1st Addnl Civil Judge and JMFC Court Gokak.

6. I state that, I have produced the necessary documents and same may kindly be marked in my favour as exhibits.

Therefore under these circumstances the plaintiffs have baselessly filed this present suit against these defendants and by suppressing the true facts. Hence suit of the plaintiffs may kindly be dismiss by imposing heavy cost in the interest of justice and equity.

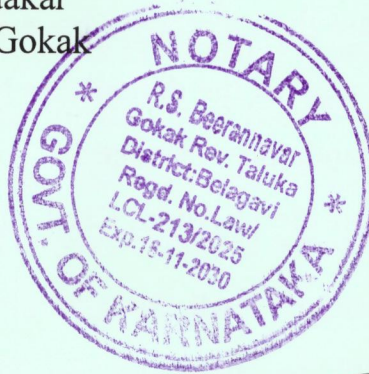

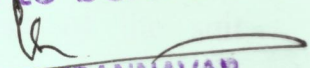
