Fresh vakalatnama filed by Sh. Akhtar Shamim,
advocate for accused Rizwan. Same is taken on record.

Report in respect of process u/s 82 Cr. PC issued
against accused Shamim @ Lala, has been filed on the record.
According to this report, this proclamation was announced in the
locality of given addresses of this accused, which were his last
known addresses, on 13.04.2024. It was also pasted on the notice
board of the court and was published in Hindi newspaper Dainik
Jagran, Delhi NCR edition on 09.04.2024. It is a matter of record
that this accused and his surety, who was his mother, have left
their given addresses without intimating the court about their
present address. In these circumstances, I am satisfied about the

proclamation u/s 82 Cr. PC being duly published. Despite lapse of a month from such publication and announcement, this accused has not appeared before this court. In these circumstances, accused Shamim @ Lala is hereby declared proclaimed offender in this case. **Intimation of this fact be sent to SHO concerned for further steps to be taken.**

Another report has been filed in respect of verification of latest address of accused Sachin @ Moppi. As per report, this address has been verified. Accordingly, personal bond furnished by accused Sachin @ Moppi on the last date of hearing, is accepted.

Ms. Tahira Bano, mother of Adil is present and she submitted that accused Adil, who is her son, has been taken into custody by police in some case of PS Khajuri, but she is not aware about particulars of such case. SI K.P. Singh from PS Khajuri Khas is present in the court and on the request of the court, he telephonically enquired about this accused, if taken in custody in any case of PS Khajuri Khas. After having telephonic conversation, SI K.P. Singh informed that accused Adil is in custody in FIR no.256/24, u/s 25 Arms Act of PS Khajuri Khas. Accordingly, issue P/Ws for accused Adil, as per aforesaid particulars for next date of hearing.
