Accused Adil and Imran absent.

1. Fresh vakalatnama filed by Sh. Arif Liyaquat for accused Israr and Tayyab. Same are taken on record.
2. Ld. counsel submits that Adil is in J/C in other case. Till date no formal application has been moved on behalf of accused Adil, to inform about particulars of any case wherein he is stated to be in J/C. Issue NBW against this accused with court notice to SHO to find out, if he is in J/C and if it is so found, then SHO shall inform the court with particulars of that case for issuance of production warrant accordingly.
3. As per report received on NBW of accused Imran, he was reported to be in J/C in FIR No. 389/2024, PS Khajuri Khas since

21.08.2024. Surety did not inform this court at all about such development. There is no explanation filed regarding absence of this accused on last date i.e. 11.07.2024. Surety Shabila is called upon to show cause as to why not surety bond be forfeited and penalty be imposed upon her for aforesaid omissions. Reply may be filed up to next date of hearing. Meanwhile, issue production warrant for accused Imran as per above mentioned particulars.

4. Insp. Amit Prakash has appeared and he has filed a request seeking more time to prepare calendar of evidence. He submits that he has been now deputed as IO, because previous IO has been transferred to other place and he needs some time to go through the file and record, to prepare the calendar of evidence. Same be filed up to next date of hearing.
