OF AFFIDAVIT

HEREIN, I, Smt.Jindabi Hasan sab Mulla, Age:  
45 years, Occ: Agriculture, R/o: Naganur, TQ:  
Ramdurg, today at Gokak do hereby state on solemn  
affirmation and make the following affidavit as  
under:-

1. I am Plaintiff in this case. I have filed this Suit  
for the relief of Declaration and partition. I know the  
facts of this case. Hence, I am competent to swear this  
affidavit. In order to avoid repetition the contents of  
the Plaint Para may kindly be treated as part and  
parcel of this affidavit.

2. The suit property is properly described in the  
plaint schedule.

3. Originally the suit property number was  
R.S.No.315/1, measuring 5.31 acres, which was  
standing in the name of original propisotus Meerasab  
Shamansab Hakki. Subsequently in the year 1975 the  
prapositus Meerasab died. After the death of Meerasab

the names of his legal heirs were entered in the property records under M.E.No.4548 of Koujalagi village. My father name Mahaboobsab was appearing in RTC of suit land till 2002. Accordingly in the year 2003 warsa was effected under M.R.No.85/2003-04. It is submitted that while doing warsa in the revenue records, my name was not shown; only the name of wife and son of my father were shown as they are the only legal heirs of deceased Mahaboobsab. I am also one of the legal heirs of my deceased father Mahaboobsab. After death of my father I have also succeed in the suit property and I also have the legitimate share in the suit property. The certification of M.R.No.85/2003-04 behind back of me and in absence of me is illegal and questionable one. I am married women and now I am residing at Naganur village of Ramdurg taluk. Hence, I am totally unaware of the changes made in the records of the suit property. It is further submitted that till today I have never relinquished my right over the suit property in favour of either my mother and my brother or anybody.

4. It is further my specific case is that, in the year 2005 the defendant No.1 and 3 entered their names in the RTC of the suit land by deleting the name of my mother and brother under M.R.No.42/2005-06. It is further submitted that, my mother and brother never transferred the share of my father in favour of defendant No.1 and 3. The defendant No.1 and 3 by using forged documents deleted the names of my mother and brother from the RTC of the suit land and entered their names by giving waradi to the revenue authorities.



5. It is further submitted that, till today there is no amicable partition between the sons of propositus Meerasab in the suit property. That my father is having 1/4<sup>th</sup> share in the suit property. That, during the life time of propositus Meerasab he was in exclusive possession and enjoyment of the suit property. After death of propositus Meerasab his sons entered their names in the RTC and are in joint possession of the suit property. That, I and defendant No.4 are in possession of our 1/4<sup>th</sup> joint share in the suit property along with defendants. I am claiming my share in the suit property in the 1/4<sup>th</sup> share of my deceased father. I and defendant No.4 succeeds the 1/4<sup>th</sup> share of deceased Mahaboobsab.

Thus, in this connection in the last week of December-2025 I asked the defendant No.1 to 3 to give my share in the suit property. These defendants by taking undue advantage of their names appearing in the RTC of the suit property denied my claim. Hence, I am constrained to file this suit for the relief of partition and declaration.

Hence, I request to decree my suit as prayed in the Plaint, to meet the ends of justice.

Hence, this affidavit.
