1. Ms. Anita Seth has filed an authority letter in her favour given by Mr. Nishant Kumar Tyagi.
2. A calendar of evidence has been filed on behalf of prosecution. IO/Insp. Vikas Rana is stated to be busy in Saket Courts.
3. Mr. Gaffar submits that no document is available in respect of absence of accused Imran for 11.07.2024. He further submits that Smt. Shabila (surety for accused Imran), did not have sufficient information about the case, wherein Imran was taken into

custody. Therefore, she could not furnish such information to this court on time.

4. Heard and perused. On last date of hearing, accused Imran had already been taken into custody in this case. In view of given explanation on the part of Smt. Shabila, she is discharged as surety without any penalty.
5. Accused Shamim @ Lala is being taken into custody in this case.
6. Mr. Praveen Yadav, Id. LAC is appointed as Id. Amicus Curiae for accused Shamim @ Lala, so as to represent him in this case also, because in other case against same accused, he has already been appointed as Id. Amicus Curiae. Accordingly, he had moved the application seeking production of accused Shamim @ Lala in this case. Mr. Praveen Yadav, Id. LAC be sent intimation accordingly about this order.
7. Put up for arguments on the point of charge on **18.12.2024**. Issue fresh court notice to IO/Insp. Vikas Rana to remain present during the arguments on the point of charge.
8. Accused persons are at liberty to file their written submissions on the point of charge, which must be filed up to next date of hearing.
