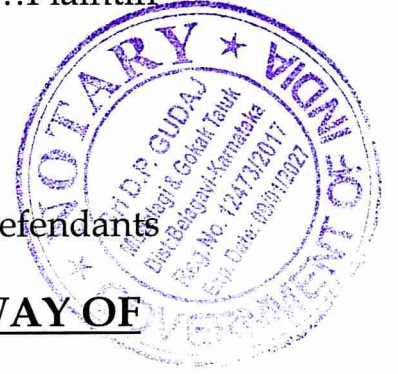
Herein I, Shri. Kallappa S/o. Siddappa Kuri, Age: 70

had two daughters they are Kenchavva Pattiyal and Renukavva i.e. plaintiff. After the death of Siddappa his widow Kenchavva and daughters by name Kenchnavva Pattiyal and Renukavva had succeeded to the suit properties as absolute owners.

3] Kenchavva Pattiyal died in the year 2011 relinquishing her right, title and interest in suit properties in favour of mother Kenchavva and plaintiff Renukavva.

4] In the life time of Kenchavva Pattiyal her husband defendant No.1 had driven her out from his house and married with another woman. The defendant No.2 to 4 are children of 2nd wife. In the life time of Kenchavva Pattiyal, herself, her mother and Renukavva were holding the suit properties jointly as absolute owners. After death of Kenchavva Pattiyal, their mother Kenchavva and plaintiff Renukavva held the suit properties jointly. After the death of mother Kenchavva in 2018 plaintiff Renukavva has become absolute owner of suit property and as such she is in possession of suit properties.

5] This being the state of affairs, defendant No.1 to 4 have illegally got entered their names in the R/R. of the suit properties and tried to dispossess plaintiff, her men, agents,
