ORDER

Plaintiff No.1 and 2, Defendant No.2, 3, 5, 6, 7(a) to (d), 8 to 14 are present. They have furnished the copies of their Aadhaar Cards. I have perused the same and satisfied.

Both parties have filed joint compromise petition U/O XXIII Rule 3 of CPC.

The contents of the compromise petition are read-over to the both parties in Kannada language known to them. They accepted the contents of the compromise petition are all true and correct. They voluntarily entered into compromise without any force.

The contents of the compromise petition are not oppose to law and public policy and on enquiry it is found that the compromise is voluntarily entered in between both the parties. Hence, the compromise is accepted.

Office is directed to draw Final Decree as per the terms and conditions of the compromise petition.

In the compromise petition in the cause title the father of Defendant No.7 is written by pen by applying whitener. In page No.6, 5th para at 11th line by applying whitener it is written as “ಅವರೊಲ್ಲರ”. In para No.6, 11th line the word “ಅತನ” is written by applying whitener.

In para No.8 at line No.10 the word “ಆತನ” is written by applying whitener. In para No.9 at 10th line the word “ಆತನ” is written by applying whitener.

Further the plaintiff No.1 and 2 and No.2, 3, 5, 6, 7(a) to (d), 8 to 14 submitted that, as per the compromised entered in between them they are in possessions their respective shares and their they will not file any petition for recovery of their shares.
