CHIEF EXAMINATION OF PW-1 BY WAY OF AFFIDAVIT

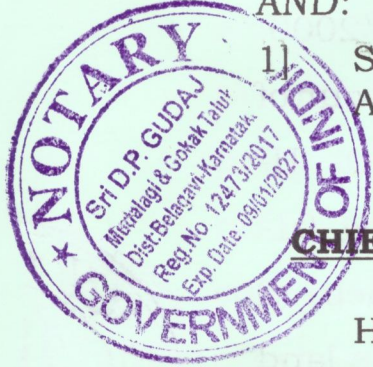
Herein I, Shri. Hanamant S/o Bhimarayappa Padamandi Age : 70 years, Occ : Agriculture, R/o: Chigadolli Tq: Gokak Dist: Belagavi, today at Gokak do hereby state on solemnly affirmation and make this affidavit as under

1. I am Plaintiff No.2 in this suit and I know the facts of the case. Hence I filed this evidence affidavit for myself and on behalf of another plaintiff no.1

2] "It is submitted that we and defendants are permanent resident of Chigadolli village Tq Gokak. Originally the suit land was measuring 06A-07Gs which was ownership of us and there ancestress out of that our father by name Bhimarayappa has got half share i.e. 03A-03Gs-08Anna and his brother by name Laxmappa has got half share i.e. 03A-03Gs-08Ann. Out of the said half portion of Laxmappa has sold 2/3rd share which comes to 02A-02Gs-08Anna in favour of Bahusaheb @

Baburao S/o Shivajirao Gorapade and remaining 01A-01Gs land has been transferred by the said Laxmappa in favour of Bhimappa Musheppa Waderahatti and he transferred the same in favour of Yallappa Siddappa Dasappanavar as per ME No.1458 dtd 20/05/1993 and again he transferred the same in favour of Parvatevva W/O Shrishail Naik as per ME NO.1727 dtd 04/12/2000. The said Parvatevva has transferred the same in favour of Vittal Bhimarayappa B Goudar as per MR NO. H-16/2017-18. which is now R.S.NO.80(1) measuring 01-01Gs which is separated. The said Bahusaheb @ Baburao S/o Shivajirao Gorapade has alienated the land to the extent of 2/3rd share land in faovur of defendant no.1 and in favour of Tammanna Bhimappa B Goudar on 23/06/1979 for consideration amount of Rs.4000/-. On the strength of the registered sale deed the name of present defendant no.1 and father of defendant no.2 where came to be enter in the record of rights as per ME No.1052 dtd 02/10/1979. Since then the present defendant no.1 and father of defendant no.2 continued the peaceful possession and enjoyment of their respective portion. Subsequently the said Tammanna Bhimappa B Goudar died and the name of defendant No.2 was entered in R/R of the suit land.

2] It is submitted that, after alienation of the above said portions we have 03Ac-03Gs-08Anna of land in the suit survey number. Inspite of above said register sale

deed of the defendants we and defendants were/are continued in joint to entire extent in the record of rights. Therefore we have requested the defendants to partition in the suit land to the extent of their shares and the shares of us in the last month. But the defendants to dragon the matter and not to partition to extent of their respective share of us and defendants they are not ready to make partition and separate possession of our properties in the suit lands. We also brought this fact before the elders of the village to make got divided the suit land to the respective portions of the defendants purchased property and remaining property of us in the suit land, for that also the defendants colluding with each other are not ready to make partition in the suit land.

3] Therefore we are constrained to file this suit for declaration that we are the absolute owners of land to the extent of 03Ac-03Gs-08Anna in the suit land and partition and separate possession of their land in the suit property against the defendants.

4. I have produced necessary documents along with plaint and same a kindly be marked on behalf of us as exhibit P-1 to ____.

Therefore it is most humbly prayed that our suit may kindly be decreed as prayed for in the interest of justice and equity.
