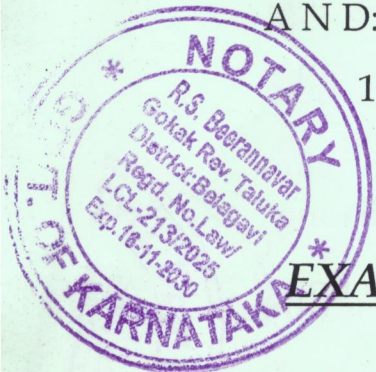
EXAMINATION IN CHIEF OF P.W.1 BY WAY

1] That I am the plaintiff in this suit. I know the facts and circumstance of this suit. Hence, I am competent to swear this affidavit.

2] I have filed this suit for declaration, permanent injunction against the defendants in respect of the suit property i.e. an Open Space property bearing GPC.No.1338, which is situated at Iranahatti village coming under Gram Panchayat Madawal, Tq: Gokak, before this Hon'ble court.

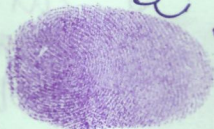
The contents of the plaint paras may kindly be treated as part and parcel of this examination of chief.

3] That, I am the permanent resident of Iranahatti village, Tq: Gokak. It is submitted that, I am the absolute owner of the suit property i.e. Open Space property bearing GPC.No.1338, which is situated at Iranahatti village coming under Gram Panchayat Madawal, Tq: Gokak. I am put in possession, use and enjoyment of the suit property since long back from my ancestors without anybody's obstruction, disturbance.

4] It is submitted that, originally the suit property is standing in the name of my father by name Satteppa S/o. Balappa Pujeri. Accordingly out of love and affection toward her daughter i.e. myself the said Satteppa had executed the relinquishment deed in my favour on:14/02/2023. Accordingly on the basis of said relinquishment deed my name is came to be entered in the property extract of the suit property as per Gram Panchayat Resolution No.5/3, dtd:07/06/2023. Though I am in actual possession, use and enjoyment of suit property and I am paying the property cess every year to the concerned Gram Panchayat authorities. It is submitted that, the defendants no way concerned to the suit property or my family at any point of time. It is submitted that, the defendants are illegally and high handedly trying to

obstruct and disturbance over my suit property without having any sole right, title and interest over the suit property which is exclusively belongs to me only. It is submitted that, the said defendants are being cruel and admanant and high handed political influenced persons, due to this they are illegally and high handedly trying to obstruction and disturbance and they have illegally obstructing to mutate / enter my name in E-Swathu (computerized) of my suit property extract before the Gram Panchayat Madawal. Further the defendants have falsely giving the false application restraining my name and by forcing to the Gram Panchayat Madawal authorities not to enter my name in E-Swathu (computerized) of my suit property extract. Further the defendants are causing obstruction to me for construction of the cattle shed over the above said open space suit property. The said illegally acts of the defendants have been recently came to my knowledge when the defendants have filed the oral false objection/ application before the Gram Panchayat Madawal. Further the Gram Panchayat Madawal authorities have also failed to enter my name on the basis of false and bogus objections filed by the defendants, and thereby the said Gram Panchayat Madawal authorities have answered to objections of defendant No.1 to 3 stating that, if they are any related or relevant documents pertaining to suit property for the same and to produce before the Gram Panchayat Madawal authorities. But the defendants have

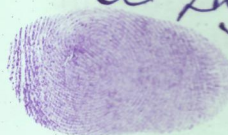

failed to any relevant and single documents before the Gram Panchayat Madawal authorities to prove that, they are the owners of the suit property. In fact the defendants are no way concerned to the suit property.

5] This being the state of affairs, on:22/11/2025 the defendants along with their henchman have came to the suit property and they are trying to cause obstruction and disturbance over the suit property to enter my name in computerized -E-Swathu of property extract, and also they are also causing obstruction to me to construct the cattle shed in the suit property. Then I have protested the same, and thereafter myself along with elderly persons have requested the defendants not to indulge such illegal activities, but the defendants are being adamant and high influenced persons they did not heed any sober request of myself and elders of the village. Thereafter I have filed the complaint on the same day before the Ankalagi Police station against the defendants, but the police authorities have told me that, it is a civil matter and they have advise that, to approach the competent court of law. Hence, I am constrained to file this suit for seeking the relief of permanent injunction against the defendants before this Hon'ble Court.

6] I have shown correct cause of action and jurisdiction and I have paid proper court fees before this Hon'ble court.

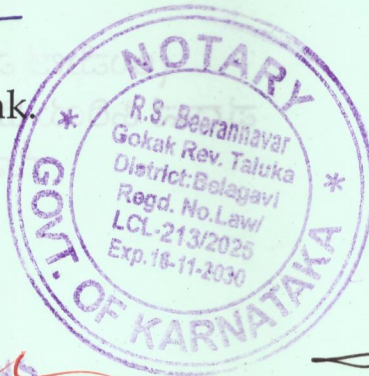
