Cross Examination of PW1 by Sri.SNL Counsel for Defendants no.9(b) and 9(c):-

1. I have studied till 2nd standard. I have made defendant no.9 as party to the suit as I need share in the suit properties. My brother Dhaklu defendant no.1 has sold R.S.No.121/2A to defendant no.9 under intoxication. My age was 10 to 11 years when above stated property was sold. My date of birth is 01-06-1971 and it is correctly mentioned in Ex.P18. I do not know whether sale deed is executed on 20-07-1991, witness volunteers that I do not know as it is executed from my brother. I came to know about the said sale deed in the year 2010. I am permanent resident of Khanapur, but for my avocation purpose I go outside. At present I reside at both Khanapur and Jaisinghpur, Maharashtra state. I do mason work at Jaisinghpur, Maharashtra. The distance between Khanapur and Jaisinghpur is about 125 Kilometers. My Aadhar Card, Ration Card and Election I.D.Card pertains to Jaisinghpur. My mother and defendant no.1 reside at Khanapur. My mother, brother and sisters were looking after the family affairs. It is true that my age was 20

years when the sale deed in the year 1991 was executed. It is true that as per the sale deed M.E.No.2592 of Khanapur was effected. I have not challenge the said mutation before any appellate authority, witness volunteers that a I have no information about it I have not challenged about it. I came to know about the said mutation in the year 2010-11.
